Georgia Board of Private Detective and Security Agencies  
Thursday, June 22, 2006

**Minutes Approved at the August 24, 2006 Meeting**

The Georgia Board of Private Detective and Security Agencies held its regular meeting on June 22, 2006 at 237 Coliseum Drive, Macon, Georgia. Mr. John Villines, Chairman called the meeting to order at 9:15 a.m.

A quorum was established with members present being: John Villines, Chairman, Tripp Mitchell, Vice-Chairman, Gary Baker, Cognizant Member, Robert Warner, Board Member, Woodrow Blue, Board Member and Vernon Keenan, Board Member.

Others present were Steve Lindsey, Executive Director, Ajay Gohill, Assistant Attorney General, and Jo Ann Lyde Application Specialist.

Visitors were as follows: Tina Elkins, Jim Persinger, William Cousin, Velda Zaporta, W. Larry Davis, John Roberson, and John Fay.

**Approval of Minutes:**

Mr. Mitchell moved to approve the minutes from the April 20, 2006 Board meeting and the June 1, 2006 Conference call. Mr. Warner seconded the motion. Motion carried.

**Approval of Agenda:**

Mr. Warner moved to approve today's June 22, 2006 agenda. Mr. Mitchell seconded the motion. Motion carried.

**Open Session:**

Mr. Villines declared Open Session:

Larry Davis discussed with the Board continuing Education and Online Training. He requested the board to provide information on continuing education rule as soon as possible in order to facilitate lesson plans for training. He also proposed that the board designate a school as a certified provider for basic training and continuing education, rather than having to submit each class for approval. Concerning online continuing education training, he encouraged the board to consider approving online training. Mr. Keenan asked Mr. Davis to present a written proposal for certification of online training for Board consideration. Mr. Villines asked for a proposal from Mr. Davis for criteria for approval of training. The members voiced support for certification of providers (school, associations, etc.) of training.

John Fay discussed online training for private investigations. He presented a set of standards for Board consideration for evaluating applicants for certified providers of online training. The members thanked Mr. Fay for bringing the printed standards for further consideration.

Tina Elkins discussed the complaint process. Ms. Elkins asked the Board if our number of investigators in the Enforcement section had increased. The Board advised her that more investigators were in place. Ms. Elkins asked about the progress of a replacement bill for the vetoed HB259. The board advised her that a replacement bill is being developed. Ms. Elkins asked about public board orders not available online. She was advised that older orders are not online yet, but can be requested in writing. Ms. Elkins asked the board to consider requiring a high school diploma or GED for registration as private detective employee. Mr. Villines expressed appreciation to Ms. Elkins for her support with the house bill.

Chairman Villines opened a discussion of the computer forensics issue by introducing Jim Persinger to present to the Board.

Mr. Villines expressed appreciation for Mr. Persinger's support of HB259. Mr. Persinger explained to the Board that data recovery or collection for court presentations meets definition of "private detective business." Technique is immaterial, but the reason for gathering data is the important matter. Data by forensics is used for further investigations. Mr. Keenan proposed that the board adopt the definition of computer forensics analysis adopted by the U. S. Department of Justice. Mr. Mitchell explained SLED requirements for licensure as private detective in computer forensics as the originator of evidence to be used in court.

Open Records Request- Mayfield, Commander & Pound, attorneys

Mr. Keenan expressed his desire to make as much information publicly available. Mr. Mitchell agreed, but expressed concern that providing application information to anyone who requests could result in abuses of requesting information. Mr. Gohill advised caution in granting blanket approval of providing information normally not subject to Open Records Act. Mr. Mitchell and Mr. Blue expressed the opinion that the board should know the reason for requests before approval. Mr. Keenan made a motion to provide the information with redacted personal information to the requestor. Mr. Warner seconded the motion. Motion carried with Mr. Mitchell abstaining.

Mr. Baker asked for updated information on the progress of a limited license recognition agreement with South Carolina. Mr. Gohill advised that licensure requirements in Georgia are substantially different than those of South Carolina. Specifically, the requirement in Georgia of 65 hours of instruction prior to licensure is not required in South Carolina. South Carolina does not require testing prior to licensure. The agreement cannot be entered into with South Carolina based on the lack of substantial criteria for licensure in 43-38-6(i). Mr. Baker made a motion to withdraw the proposal and to notify South Carolina. Mr. Mitchell seconded the motion. Motion carried unanimously.

**Executive Session:**

Mr. Mitchell made a motion to enter into Executive Session to deliberate on applications and complaints and to receive information on investigative reports. Mr. Keenan

seconded the motion. Motion carried by Mr. Villines, Mr. Blue, Mr. Baker and Mr. Warner.

**Applications:**

Jo Ann Lyde, Application Specialist, presented applications to the Board.

**Appointments:**

The Board met with individuals scheduled for appointments to discuss application issues.

**Investigations:**

Leigh Medcalf-Hall, Investigator with the Enforcement Section, presented investigative reports to the Board.

**Attorney General Report:**

Ajay Gohill, Assistant Attorney General, presented a status report.

**Open Session:**

Mr. Villines declared Open Session.

**Appeals:**

R W C met with the Board today concerning an appeal. Mr. Mitchell made a motion to license by consent order with two years probation, no arrests, violations, or citations within that two years and to require applicant to submit to drug and alcohol evaluation within thirty days and report that evaluation to the Board. Mr. Warner seconded the motion. Motion carried.

Broderick Kizzie did not keep his appointment with the Board.

Curt Escher- Mr. Mitchell moved to approve Mr. Escher's application for licensure. Mr. Warner seconded the motion. Motion carried.

Patrick Protective Service: Mr. Mitchell moved to approve the company license. Mr. Keenan seconded the motion. Motion carried.

Joseph Simon Fleischer- Mr. Keenan made a motion to approve the application for licensure. Mr. Warner seconded the motion. Motion carried.

Edward Elvin White- Mr. Mitchell moved to uphold the board's previous decision to deny, due to federal and state law prohibiting possession of a weapon by a convicted felon, and for misrepresentation of material fact on application. Mr. Blue seconded the motion. Motion carried.

Oscar Summerlin did not keep his appointment with the board.

L S W- Mr. Mitchell moved to approve licensure by consent order with two years probation, no sustained complaints, and must maintain accurate records for Board review. Mr. Warner seconded the motion. Motion carried.

R H- Mr. Keenan move to table the decision until resolution of P.O.S.T. case. Mr. Warner seconded the motion. Motion carried. Mr. Mitchell abstained from the vote.
