February 22, 2007 9:00 a.m.

Mr. Baker moved, Mr. Warner seconded, and the Board voted to send a letter to the Georgia Prosecuting Attorneys Council stating the Board's concern about the lack of prosecution of unlicensed practice cases and to request a dialogue concerning the issue.

The Board reviewed a written request from Allen Nooner for a grace period in which to keep a private detective company operating while obtaining a qualified license holder. The Board noted that a recent amendment to Board Rule 509-2-.03 allow the Board to grant a 180-day grace period in this circumstance. Mr. Warner moved, Mr. Blue seconded, and the Board voted to grant a 180-day grace period to Mr. Nooner.

The Board reviewed an Open Records Request for application information from Shannon McCafferty. After discussion of the request, Mr. Warner moved, Mr. Blue seconded, and the Board unanimously voted to deny her request.

The Board reviewed correspondence from Brinks, Inc. regarding registration of certain in-house security employees. Mr. Baker moved, Mr. Warner seconded, and the Board voted to send written response advising Brinks, Inc. that the exemption in OCGA § 43-38-14 (d) does not apply to private security companies required to be licensed in the state, and that all armed employees of the company must be registered with the Board.

There being no further business, the meeting adjourned at 12:45 p.m.
