Thursday, June 21, 2007

A meeting of the Georgia Board of Private Detective and Security Agencies was held on Thursday, June 21, 2007 at 237 Coliseum Drive, Macon, GA. James T. Mitchell, Chairman, called the meeting to order at 9:10 a.m.

A quorum was established with members present being: James T. Mitchell, Chairman, Robert Warner, Vice-Chair, Gary Baker, Woodrow Blue, Robert Warner, and John Villines.

Others present were: Steve Lindsey, Executive Director, JoAnn Lyde, Applications Specialist, Laurie Elander, Board Secretary, Maria Stephenson, Investigative Assistant, and Ajay Gohil, Attorney General.

Approval of Minutes:

Mr. Warner moved, Mr. Villines seconded, and the Board approved the minutes of the April 26, 2007 minutes.

Other Business:

Mr. Warner moved, Mr. Blue seconded, and the Board voted to suspend the licenses of Crystal G. Battle, license number SGE051064; Poncellis Evans, license number SGE051774; and Kasshe L. Perkins, license number SGE051886, for failure to repay student loans, and further moved that these suspensions will cease upon receipt by the Division Director of a "Notice of Release" from the Georgia Higher Education Assistance Corporation.

He advised the Board that all investigators and inspectors throughout the divisions of the Secretary of State's Office will be consolidated into one unit under the direction of Inspector General Shawn LaGrua. Better customer service was also discussed. Secretary Handel committed to improving customer service, specifically in reference to the Call Center

Effective September 1, 2007, a line will be added to Applications for Company Licensure to include that a notarized copy of a certificate of training completion must be attached with the application.

The Board discussed an e-mail from Doni Holcomb of Loomis and requested a letter to be sent to Loomis requesting records directly from physician in charge of the employee.

The Board requested a letter to be sent to Loomis for updates on employee arrest as information is available.
