A meeting of the Georgia Board of Private Detective and Security Agencies was held on Thursday, November 29, 2007 at 237 Coliseum Drive, Macon, GA. James T. Mitchell, Chairman, called the meeting to order at 9:00 a.m.

A quorum was established with members present being: James T. Mitchell, Chairman, Robert Warner, Vice-Chair, Gary Baker, Vernon Keenan, Patricia Mincey and John Villines.

Approval of Minutes:

The Board approved the minutes of the October 18, 2007 minutes by a unanimous vote.

Exam Sub-Committee: Next meeting January 23, 2008 at 2:00

Armored Car Training: Request made to include vault training in 24-hour security training. Sub-committee of Tripp Mitchell and Pat Mincey are reviewing criteria for specialized training for armored car employees.

Mr. Mitchell discussed with the Board members the possibility of requiring a 24 or 48-hour course for applicants for company licensure prior to receiving a license. The course will cover state laws, board rules, business practices, complaint process, unlicensed practice, and other legal issues pertaining to the industry. 43-38-6 (b) (9).

Request from Chuck Weeks regarding Board Rule 509-4-.01. The Board determined that the rule is correct, and a .38 caliber revolver is allowed under the rule.

Mr. Warner motioned, Mr. Blue seconded, and the Board voted to appoint Mr. Villines and Mr. Keenan to sub-committee to draft rule amendment to create self-executing sanctions against employees and companies who do not comply with continuing education and firearms training.
