A meeting of the Georgia Board of Private Detective and Security Agencies was held on Thursday, March 27, 2008 at 237 Coliseum Drive, Macon, GA. James Mitchell, Chairman, called the meeting to order at 9:06 a.m.

A quorum was established with members present being: James Mitchell, Chair, Robert Warner, Vice-Chair, Vernon Keenan, Patricia Mincey, Woodrow Blue and John Villines.

Others present were: Steve Lindsey, Executive Director, JoAnn Lyde, Applications Specialist, Laurie Elander, Board Secretary, and Patricia Downing, Assistant Attorney General.

Approval of Minutes:

Ms. Mincey moved, Mr. Villines seconded, and the Board voted approve the January 24, 2008 minutes.

Dr. Obadiah T. Yusufu presented to the Board the 2007 Annual Examination Report. Statistical information from 2007 exams was provided along with the goals for 2008. Mr. Mitchell asked for criteria for choosing subject matter experts. Mr. Yusufu explained that corrections were made to determine the criteria. Mr. Mitchell requested for the Board to have input on setting criteria for choosing qualified subject matter experts. Mr. Mitchell asked if the Board to have input on the relevancy of questions being included on exams. Mr. Yusufu announced that a workshop will be held on May 15, and he invited the exam sub-committee members to the workshop to see how it is conducted.

Executive Session:

Mr. Warner moved, Mr. Blue seconded, and the Board voted unanimously to enter into Executive Session to deliberate on applications, complaints, and investigations, as authorized by OCGA § 43-1-2 (k) and 43-1-19 (h).
