

Georgia Board of Private Detective and Security Agencies

Board Meeting

August 25, 2011

The Georgia Board of Private Detective and Security Agencies held its regularly scheduled meeting on Thursday, August 25, 2011 at 237 Coliseum Drive in Macon, Georgia. Tripp Mitchell called the meeting to order at 9:14 a.m.

A quorum was established with members present being: James (Tripp) Mitchell, John Villines, Director, Vernon Keenan; Robert Warner and Chief, Woodrow Blue, Jr.

Others present were: Steve Lindsey, Executive Director; Scarlett Shell, Assistant Attorney General and Melanie Brown, Board Support Specialist.

Guests in attendance were as follows: Joseph S. Memolo Executive Director of ISPAG, Benjamin Zeifman, Saabu Bey and Geald Miller.

Joseph Memolo, Executive Director of ISPAG, addressed the Board regarding HB53, stating that his organization opposed the bill for reasons of unfair competition.

Sabou Bey, with Value Guard, questioned the Board regarding the licensing process for company licensure applications. Tripp Mitchell replied that measures have been implemented by the Board to expedite the application process as much as possible. The Board has approved guidelines and measures to allow board staff to administratively issue as many licenses as possible with regard to public interest and ensuring regulatory compliance under the law.

The meeting agenda was adopted and approved by unanimous consent.

The Board voted to approve the minutes of previous board meetings of the April 21, 2011, by unanimous consent.

Executive Session:
