Board Meeting

October 27, 2011

The Georgia Board of Private Detective and Security Agencies held its regularly scheduled meeting on Thursday, October 27, 2011 at 237 Coliseum Drive in Macon, Georgia. Chairman Glade Johnson called the meeting to order at 9:13 a.m.

A quorum was established with members present being: Glade Johnson, Chairman; John Villines, James (Tripp) Mitchell and Robert Warner.

A Public Hearing was scheduled for 10:00 a.m. on Thursday, October 27, 2011 at 237 Coliseum Drive, Macon, Georgia for the purpose of determining whether to sanction the licenses of Apex Executive Services to operate a private security company in the State of Georgia. The Public Hearing was cancelled due to lack of proof of service of the Notice of Hearing, and due to the board staff receiving additional documents from the owner that provided proof of regulatory compliance for the Board to review.

John Villines moved, Tripp Mitchell seconded, and the Board voted to accept the documents as submitted and to request that the Attorney General draft an order to dismiss the Public Hearing. The Board voted to accept the signed Order upon receipt from the Attorney General.

Tripp Mitchell moved, John Villines seconded, and the Board voted to form a committee to partner with companies on creating guidelines to expedite the application process for those affected by HB 53. The committee will include Tripp Mitchell and Glade Johnson.

The Board discussed rewriting the continuing education rule to allow webinars and industry leaders to teach courses without mandating that the instructors become Board certified trainers.

Tripp Mitchell moved, John Villines seconded, and the Board voted to accept the ASIS Law Enforcement Summit's continuing education units as CE credit for licensure renewal.

The Board has been contacted by Jack Fey to amend the licensing examination due to questions of irrelevant content appearing on the exam. John Villines suggested collaborating with Subject Matter Experts (SMEs) and include Mr. Fey to formulate approximately 75% of the exams questions from the Georgia Code, create a document of best practices and develop study material that can be obtained by applicants. This would provide some study material for applicants and offer guidance as to what applicants can expect when taking the exam.

Tripp Mitchell moved, John Villines seconded, and the Board voted to invite Craig Fluck to the December meeting to discuss amending the licensing examination. The Board would like Mr. Fluck to answer questions surrounding:

1. When can changes be made to the exam, specifically within what timeframe or timeline?
2. What budgetary restraints or support would apply if the Board moves forward with amending the licensing exam?

The Board plans to continue this discussion at the December board meeting.
