Board Attorney, Becky Adams, delivered the Attorney General's Report. She informed the board she took part in an Office of State Administrative Hearings (O.S.A.H.) hearing involving applicant Earnest Shaw. She informed the board that the administrative law judge made a ruling from the bench and will issue a written decision in the next 30 days. Ms. Adams further informed the board that another applicant has filed a Petition to Reconsider regarding the denial of the applicant's application.

Executive Director, Kyle Floyd, delivered to the board a report in which he made a couple of inquiries. First, does the board want to review all examination

applications or have they considered granting administrative approval authority to board staff?

A motion was made by Tommy Holder, seconded by Hoppy Hopkins, and the General Contractor Division voted unanimously that board staff may approve applications for examination with the same restrictions that were formerly placed upon such authorization by the Residential Basic Division and its Light-Commercial subdivision when allowing board staff to approve applications for licensure by examination exemption. A motion was made by Bob Barnard, seconded by Mark Herbert, and the Residential Basic Division voted unanimously that board staff may approve applications for examination with the same restrictions that were formerly placed upon such authorization by the Residential Basic Division and its Light-Commercial subdivision when allowing board staff to approve applications for licensure by examination exemption. A motion was made by Tim Ansley, seconded by Steve Cash, and the Residential-Light Commercial subdivision voted unanimously that board staff may approve applications for examination with the same restrictions that were formerly placed upon such authorization by the Residential Basic Division and its Light-Commercial subdivision when allowing board staff to approve applications for licensure by examination exemption.

The second inquiry was whether the Board would vote to allow those applicants who were formerly officially denied due to the legally mandated five year requirement but who might now be reconsidered because of the passage of SB115 to be reconsidered without a specific vote on such applicant?

The Board discussed new business items.

Chairperson Huggins discussed specialty contractors and the board's responsibility in defining such, and distributed a list of such, broken into two groups. The first group is subcontractor types, and thus not prime contractors. The second group actually pull permits and oversee subcontractors but the work is so specialized it was never meant to fall under the scope of the residential and general contractor law.

Kevin Veler, attorney representing Georgia Association of Pool & Spa Professionals, spoke to the 25 percent portion of the law and SB115 and the problems his industry is having with its potential impact.

After discussion of the list, Chairperson Huggins, Bob Barnard, and Morgan Wheeler volunteered to serve on a committee to consider defining the specialty contractors as set forth in SB115.

Mark Woodall, of the Associated General Contractors of Georgia, provided a handout about the newly passed SB115, providing a line by line breakdown of the bill's changes to the current law.

Dave Cyr and Tommy Holder volunteered to serve on a committee to consider allowing for tiers/levels of contracting under the general contracting division.

Chairperson Huggins announced he would like to, sometime in the future, look at creating a rule on advertising and use/requirement of a licensee's license number on such advertising.

With no other business for the Board to discuss, Chairperson Huggins adjourned the meeting at 12:47 p.m.
