Scarlett Elliott, Board Attorney, delivered the Attorney General's Report.

Ms. Elliott presented six (6) Consent Orders for acceptance by the Board. These orders had been drafted by Ms. Elliott at the board's request, mailed to the relevant applicant, and returned to Ms. Elliott signed by the applicant.

A motion was made by David Cyr, seconded by Mark Herbert, and the Board voted unanimously to accept the consent orders.

At the October meeting, Ms. Elliott was asked by the Board for clarification regarding whether the full board could vote on matters or whether each division needed to break up and vote separately. Ms. Elliott stated that O.C.G.A. § 43-41-4(f) provides, in part, that "each division of the board shall operate and transact its business independently of the other division and of the board at large, except as required by this chapter and to the extent of common interests and functions, including staffing and administration." O.C.G.A. § 43-41-4(h) states that "[t]he board shall not take action on any matter specifically delegated to and under the authority and control of the one of its divisions unless at least four of its members from the affected division are present and participating in such action or decision," so it appears that the full board can vote on matters concerning one division as long as four members of the affected division are present and participating.

Ms. Elliott was asked by the Board for clarification on whether or not the offenses of gambling and cruelty to animals were considered crimes of moral turpitude. Ms. Elliott stated that gambling is not considered a crime of moral turpitude. Cruelty to animals would be considered moral turpitude if it is a felony charge, but it is not clear from the cases whether a misdemeanor charge would be considered moral turpitude.

Kyle Floyd delivered the Executive Director's Report.

Mr. Floyd stated that the Board needed to set the calendar for 2008.

A motion was made by Morgan Wheeler, seconded by Mark Herbert, and the Board voted unanimously to set the calendar for the following 2008 meeting dates:

Mr. Floyd discussed a letter he received from Hart County Habitat for Humanity. They would like a ruling on whether or not they will have to hire a licensed contractor or whether they can receive an exemption from licensure. Mr. Floyd asked Scarlett Elliott, Board Attorney, to look into this matter.

Committee Reports were discussed.

Bob Barnard, Specialty Contractor Committee Chairman, stated that a copy of the October 24, 2007 minutes were given to each Board member. He stated that the committee would like to go ahead and post the list of specialty contractors previously created by the committee and then modify the list if needed.

A motion was made by Bob Barnard, seconded by Mark Herbert, and the Board voted unanimously to post the list of specialty contractors with modifications made at the committee meeting to the Secretary of State website.

Scarlett Elliott, Board Attorney, stated that she was not included in the committee meeting that was held on October 24, 2007 and has not reviewed the list that the Board voted to post.

David Cyr, Building Official Notification/Pre-Licensing Affidavit Chairman, stated that this committee has not met yet. However, they will meet before the next Board meeting. Morgan Wheeler and Penelope Round, Atlanta Home Builders Association, informed everyone they have passed out notices of the forthcoming licensure effective date to the building officials statewide.

Bob Barnard, Written Warranty Committee, discussed the draft of the written warranty requirements.

A motion was made by Bob Barnard and seconded by Philip Thayer to post the written warranty requirements. Request for discussion was called.

Kyle Floyd, Executive Director, stated that a rule has been posted before regarding this warranty. Thus, what is being requested in this motion would be another rule to replace the former rule. Morgan Wheeler expressed some concern over the new language. Bob Barnard stated that further discussion needs to be held.

The motion was withdrawn.

The issue of notifying all Board members via e-mail as to when the committee meetings are held was discussed. Mr. Floyd stated that the Board is only required to post the meeting date/time in the lobby of the Professional Licensing Boards and that regular board meeting dates are posted on the Secretary of State website.

A motion was made by Philip Thayer, seconded by Bob Barnard, and the Board voted unanimously to add Morgan Wheeler to the Written Warranty Committee.

Allen Richardson, Reciprocity Committee, stated that the committee met and decided to defer conversation on the topic until at least a year after licensing of contractors becomes effective. He stated it will be best to wait a couple of years and then talk to other states.

Discussion ensued.

Bob Barnard stated that, as a courtesy, a letter needs to be sent out to the other states.

A motion was made by David Cyr, seconded by Morgan Wheeler, and the Board voted to defer consideration of reciprocity for at least one year following the July 1, 2008 licensing start date and that a letter be written to neighboring states who have requested reciprocity to notify them of the Board's decision.

Old/New business items were discussed.

A motion was made by Bob Barnard, seconded by Mark Herbert, and the Board voted to do the following concerning non-drug related convictions involving fraud or forgery: If the conviction for fraud or forgery is more than 10 years old and criminal probation has ended, then a mandatory 24 month probation would be placed on the license. If the conviction is less than 10 years old, then the license will be placed on a 24 month probation or probation to run concurrent with the applicant's criminal probation, whichever is longer.

Kyle Floyd, Executive Director, stated there are 38 exam exemption applications that are untouched and the number should have dropped to zero by the end of the meeting.

There are currently 6,000 to 7,000 pending exam exemption applications to be further processed.

Roger Huggins stated that we need more bodies to come in and review applications.

Mr. Floyd stated that he would like to give credit to Roger Huggins, Morgan Wheeler and Timothy Ansley for coming in each week and keeping the number of General Contractor applications to be reviewed down. Mark Herbert has come in and done a good job keeping the Residential Basic numbers down.

Chairperson Thayer asked Mr. Floyd to please thank staff on behalf of the Board for a job well done.

Mr. Huggins asked Penelope Round, Atlanta Home Builders Association, to edit and rearrange the final list on the specialties. Ms. Round stated that she would and then forward the final version to Mr. Floyd for posting, per the motion made earlier.

With no other business for the Board to discuss, a motion was made by David Cyr, seconded by Bob Barnard, and the Board voted unanimously to adjourn the meeting at 4:05 p.m.
