At 9:14 a.m., Chairperson Thayer established that a quorum was present and called the meeting to order.

A motion was made by Timothy Ansley, seconded by Roger Huggins, and the Board voted unanimously to accept the November 7, 2007 full Board meeting minutes.

Chairperson Thayer discussed when he, along with other Board Chairpersons, met with Karen Handel, Secretary of State, on Monday, December 3rd. Items discussed were consent orders and investigations. There were not any complaints concerning this Board, which speaks a lot, according to Mr. Thayer, considering the volume of applications the Board handles. Chairperson Thayer stated that staff is doing a good job.

Tanja Battle, Deputy Director, stated that the Executive Directors also met with Ms. Handel following the Board Chairperson meeting. They discussed the complaint process. This currently does not affect this Board, but will in the near future. Ms. Handel understands our main thrust is getting through all of the applications.
