Ms. Elliott presented two Consent Orders for acceptance by the Board. These orders had been drafted by Ms. Elliott at the board's request, mailed to Residential Light Commercial Contractor applicants Andrew D. Bentley and Paul Gregory Lindsey, and returned to Ms. Elliott signed by Mr. Bentley and Mr. Lindsey. The Consent Orders for Mr. Bentley and Mr. Lindsey allow them to be licensed under probationary terms.

That is, applicants must show a minimum net worth of \$150,000 and a line of credit in a minimum amount of \$50,000.

A motion was made by Allen Richardson, seconded by Mark Herbert, and the Residential Division voted unanimously to require a \$25,000 letter of credit or a \$25,000 bond on any new company.

Discussion ensued.

Kevin Veler, of Legal Counsel for Business and Construction, suggested the board consider whether some builders can afford the line of credit or bond. Mr. Floyd reminded the board it is their foremost responsibility to consider the protection of the public and it could be a detriment to the public, as homeowners, to approve, through licensure, such applicants. Bob Barnard agreed.

A motion was made by Allen Richardson, seconded by Mark Herbert, and the Residential Division voted unanimously to amend the previous motion and require a \$25,000 line of credit or a \$25,000 bond on any new company.

Discussion ensued.

The previous motion was withdrawn by Allen Richardson, seconded by Mark Herbert.

A motion was made by Allen Richardson, seconded by Mark Herbert, and the Residential Division voted to require a \$25,000 line of credit or a \$25,000 bond if the exam applicant cannot meet the current financial requirements that currently exist.

Mr. Floyd stated that the board needs to decide on additional meeting dates.

Chairperson Thayer stated that about 10 percent of applicants denied are seeking an appearance before the board. The Secretary of State is requesting the board host these appearances by April 1, 2008. Chairperson Thayer stated that the board can meet, to fulfill this request, back to back days or meet twice a month to accomplish this goal.

Discussion ensued.

It was decided by the board to meet on the following dates: January 30, 2008, February 27, 2008 and March 26, 2008. These dates are in addition to the monthly board meetings already posted and planned for the sole purpose of hosting appearances.

New Business items were discussed.

“Portability” of licenses was discussed. Portability involves, basically, somebody transferring an approved qualifying agent or individual status they already have to another company that did not previously meet the five year requirement. Mr. Huggins suggested establishing a committee to handle this issue. Mr. Huggins asked Mr. Floyd to come up with a form for the board to approve that will facilitate this process.

Mark Woodall, of the Associated General Contractors of Georgia, stated that there are individuals out there that received approval status for an entity that does not exist anymore.

Bob Barnard stated this is an issue he wanted to bring up in new business.

Penelope Round, Atlanta Home Builders, stated that bankruptcy is only part of this issue and that the applicant could have been fired.

Mr. Barnard asked if the board should post a rule about this issue.

Mr. Floyd asked Scarlett Elliott, Board Attorney, to look into this issue. That is, does an applicant still have to be affiliated by ownership or employment with the business organization for which he or she was approved in order to be able to transfer this status?

Mr. Barnard stated there should be a form wherein the applicant could put all of the companies with which he or she is associated. Timothy Ansley stated that he has seen plenty of applications where the applicant may be associated with six different companies.

Discussion ensued.

David Cyr stated that the law says the qualifying agent is to notify the board when the status of the company in which he or she applied for changes.

Mr. Huggins stated that there is a need for a less restrictive license type on the general contractors side. The board needs to look at doing what is necessary to set this in motion following the law passed during the last legislative session. Mr. Huggins stated the board should possibly establish a committee and create an easier way in on the General Division's side.

Timothy Ansley, Roger Huggins and David Cyr will be on this new committee, with Mr. Huggins as the Chairperson. This new committee will be called the General Contractor tier committee.

There were no old business items to discuss.

No committee had anything to report.

With no other business for the Board to discuss, a motion was made by Bob Barnard, seconded by Timothy Ansley, and the Board voted unanimously to adjourn the meeting at 4:55 p.m.
