

The State Licensing Board for Residential and General Contractors met on July 9, 2008 at the Professional Licensing Boards Division, 237 Coliseum Drive in Macon, Georgia, for the purpose of conducting Board business.

At 8:03 a.m., Chairperson Hopkins established that a quorum was present and called the meeting to order.

A motion was made by Tommy Holder, seconded by Roger Huggins, and the Board voted unanimously to accept the June 18, 2008 full Board meeting minutes.

A motion was made by Bob Barnard, seconded by Timothy Ansley, and the Board voted unanimously to accept the June 27, 2008 full Board Conference Call minutes.

There were no old business items to discuss.

New business items were discussed.

Roger Huggins asked if an applicant fails the examination twice, can the applicant apply to take the examination for a different license type. Tanja Battle, Executive Director, stated yes. Mr. Huggins then asked if the applicant can qualify another company under the same license type, or apply as an individual under the same license type if he/she fails the examination twice. Ms. Battle stated no.

Tanja Battle, Executive Director, discussed proposed Rule 553-7-.02, Written Warranty for General Contractor. She asked the Board to please review the rule and if there are no changes it can be posted.

A motion was made by Tommy Holder, seconded by Bob Barnard, and the Board voted unanimously to post Rule 553-7-.02, Written Warranty for General Contractor.

Ms. Battle referred the Board to a draft of a new chapter in the rules regarding unprofessional conduct. Rule 553-9-.01, Failure to Maintain General Liability Insurance, was discussed. Ms. Battle informed the Board that when a notice of a cancellation of insurance is received in the Board office by staff, a letter is sent to the applicant stating that he/she has 15 days to submit current insurance. There is currently no requirement in the law stating that insurance has to be maintained. She suggested that if the Board wants to require maintaining the insurance they should do so by rule.

Bob Barnard referred to item (2) of the proposed rule which reads, "Failure to maintain such will result in disciplinary action". He asked if the Board should state exactly what the disciplinary action should be.

A motion was made by Bob Barnard, seconded by Tommy Holder, and the Board voted unanimously to post Rule 553-9-.01, Failure to Maintain General Liability Insurance, and to allow staff to modify the rule by stating what the disciplinary action should be.

Ms. Battle discussed a proposed rule for an inactive license. Ms. Battle stated that Mrs. Durden referred to other Board's guidelines for creating the draft of the rule. She asked the Board to review and if they approve, it will be ready to post.

Discussion ensued.

A motion was made by Bob Barnard, seconded by Tommy Holder, and the Board voted unanimously to post the rule regarding an inactive license.

Ms. Battle discussed a proposed rule regarding changes in status. Ms. Battle stated this addresses when licensees must notify the Board when a change in status has occurred, such changes in name, address or location, if a qualifying agent leaves a business organization, etc. Mrs. Durden is in the process of working on this rule.

Chairman Hopkins stated that at this time the Board will table the proposed rule regarding change in status.

In regards to the proposed Inactive License rule, Ms. Elliott stated the Board cannot vote to post this version because it does not have a number assigned to it. Lisa Durden stated that number 553-10-.01 has been applied to this rule.

Scarlett Elliott, Board Attorney, delivered the Attorney General's Report.

Ms. Elliott presented two Consent Orders for acceptance by the Board. These orders had been drafted by Ms. Elliott at the Board's request, mailed to applicants Anthony Storm Ogle and Michael Gene Rewis, and returned to Ms. Elliott signed by the applicants. The Consent Orders for these applicants allow them to be licensed under probationary terms.

A motion was made by Bob Barnard, seconded by Morgan Wheeler, and the Board voted unanimously to accept the Consent Orders.

Tanja Battle delivered the Executive Director's Report.

Ms. Battle stated that now that the licensure requirement is in effect, the Board will be receiving complaints to consider. Ms. Battle stated that as complaints are received, staff will enter them into our database, acknowledge receipt by notifying the complainant, and refer to the Cognizant member for recommendations.

Ms. Battle referred the Board members to a handout regarding company affiliation. Ms. Battle drafted this per Roger Huggins, who would like to get the Board's thoughts on this item. The questions would track a qualifying agent's affiliation with the old and new company.

Mr. Huggins stated that he has a lot of concerns regarding the Prior Approval applications. He is trying to watch for applicants who should have never been approved as Qualifying Agents. Timothy Ansley stated he has seen numerous superintendents that had the project manager sign for the company without the owner's knowledge.

Ms. Battle stated that the Board can vote to incorporate the form regarding company affiliation into the Prior Approval applications, if they are satisfied with the questions.

Tommy Holder asked about all the other qualifying agents who had already been approved. Mr. Huggins stated that this would only come up for those applicants that have gone to another company and are now applying by prior approval status.

Mr. Huggins stated that as a Board member reviews these applications, and if one comes into question, the Board member can contact the applicant for further clarification.

Ms. Elliott stated that if an application comes into question, the Board member needs to make notes and have staff send a letter to the applicant so that there is documentation of the inquiry.

Mr. Barnard stated that it may be simpler for staff to go back through all the qualifying agent applications signed by a superintendent and send a letter to them.

Mr. Huggins stated that at the last meeting of the Qualifying Agent Committee, a recommendation was made for staff to send letters out to the Qualifying Agent and the person that signed the Qualifying Agent Affidavit requesting clarification if: a) Qualifying Agent represents two or more firms; and b) firms that have 3 or more Qualifying Agents. This letter should make it clear what sanctions may be imposed for falsely filing an application.

Mr. Barnard expressed his concerns stating that he feels this is going to create a problem legally because the Board has already approved these licensees and now the Board wants to go back and review all of them again. Mr. Barnard stated that the Board must be careful as to how to word the letter.

Mr. Huggins stated that the purpose of this is to strengthen the application. He stated that the subcommittee recommended that staff send a letter to these applicants and give them a chance to say they misunderstood what he/she was signing.

Ms. Elliott stated that the Board will not be able to revoke a person's license without an administrative hearing first.

Discussion ensued.

A motion was made by Roger Huggins, stated by Tommy Holder, and the Board voted unanimously to have staff send a letter to all business organizations with three or more qualifying agents, and to all qualifying agents representing three or more firms. This letter should make it clear what sanctions may be imposed for falsely filing an application. Mr. Huggins added that the Board should allow the person who comes forward to keep his/her license. He stated if that is too broad he will remove it from the motion.

A motion was made by Roger Huggins, seconded by Bob Barnard, and the Board voted unanimously to add the language regarding company affiliation to the applications for prior approval status.

Ms. Battle discussed the upcoming NASCLA (National Association of State Contractors Licensing Agencies) conference. The annual conference is being held in Point Clear, Alabama on September 14, 2008 through September 18, 2008. Ms. Battle asked if there were any Board members interested in attending this year. There were none.

Lisa Durden, Executive Director, discussed a letter received from Doug Hansford, Director of Athens-Clarke County Building Inspection Department. The letter asks whether employees of local government who perform renovation work to county owned buildings and facilities need to hold a General Contractors license.

Mr. Barnard asked if government entities do their own work. Morgan Wheeler stated yes. Mr. Huggins stated that is a Public Works law. He stated the law concerning Residential and General Contractors does not have any exemptions for cities and counties doing their own work. Edward Strain stated that it is a question of the law; how can you tell a government entity what projects they can do.

Discussion ensued.

Chairperson Hopkins asked Ms. Elliott to research this issue and report back to the Board.

Chairperson Hopkins called the hearing on adoption of Rule 553-7-.01, Written Warranty to order at 9:05 a.m.

Chairperson Hopkins called for public comments, written and oral, on proposed Rule 553-7-.01, Written Warranty.

Bettie Sleeth, Home Builders Association of Georgia, stated that the HBAG supports this rule and thinks it is a good step. There were no other comments.

Chairperson Hopkins asked for a motion from the Residential Division regarding adoption of Rule 553-7-.01, Written Warranty. Bob Barnard made the motion, Allen Richardson seconded, and the Board voted unanimously to adopt the rule.

Committee Reports were discussed.

Bob Barnard, Specialty Contractor Committee, referred the Board to a handout in reference to Residential Kitchen and Bath Designers/Installers, which Kevin Veler, of Legal Counsel for Business and Construction, prepared and sent to Mr. Barnard. Mr. Barnard's concern is that the memo does not clarify "management and oversight".

Mr. Barnard presented two definitions:

- Kitchen and bath designers may only design, help the owner in the selection of materials, and verify with the "contractor" their design and selections.
- Cabinet installers may remove existing cabinets, install new cabinets, and counter tops. May install appliances as long as all connections are already in place.

Discussion ensued.

Mr. Barnard stated that the Specialty Contractor Committee will need to have a conference call to further discuss this issue. Mr. Kevin Veler, representing the NKBA, asked the Board to consider moving forward with Mr. Barnard's definition.

A motion was made by Bob Barnard, seconded by Mark Herbert, and the Board voted to table this issue until the Specialty Contractor Committee can further discuss.

Chairperson Hopkins asked the Board to cease discussion on Committee Reports at this time.

A motion was made by Bob Barnard, seconded by Steve Cash, and the Board members present: Hopy Hopkins, Philip Thayer, Timothy Ansley, Bob Barnard, Steve Cash, Mark Herbert, Tommy Holder, Roger Huggins, Allen Richardson, Edward Strain and Morgan Wheeler, voted unanimously to enter into Executive Session for application discussion.

Open Session was declared by Chairperson Hopkins.

An Open Records Request was submitted by Charles H. Van Horn, Esquire, regarding applicant M.J.L. (Residential Basic Qualifying Agent). A motion was made by Philip Thayer, seconded by Mark Herbert, and the Residential Division voted unanimously to deny the open records request.

Ms. Elliott presented one Consent Order for acceptance by the Board. This order had been drafted by Ms. Elliott at the Board's request, mailed to applicant Kenneth J. Smith, and returned to Ms. Elliott signed by the applicant. The Consent Order for this applicant allows him to be licensed under probationary terms.

A motion was made by Philip Thayer, seconded by Mark Herbert, and the Board voted unanimously to accept the Consent Order.

Discussion on Committee Reports resumed.

Mr. Barnard presented several more items for discussion by the Specialty Contractor Committee. Mr. Huggins asked that he be allowed more time to review these items and the Specialty Contractor Committee can discuss these at the next scheduled conference call.

The Building Official Notification/Pre-Licensing Affidavit Committee had nothing to report at this time.

Philip Thayer, Written Warranty Committee Chairman, stated the Board adopted Rule 553-7-.01, Written Warranty this date.

The Reciprocity Committee had nothing to report at this time.

The General Contractor Tier Committee had nothing to report at this time.

Roger Huggins, Qualifying Agent Committee Chairman, stated he would like the subcommittee to try and create some guidelines to go by when reviewing applications. Ms. Elliott stated that if there is anything questionable, have staff send a letter to the applicant requesting further clarification. Mr. Huggins stated he would have staff get further clarification if he has questions.

The Inactive Status Committee had nothing to report at this time.
