

The State Licensing Board for Residential and General Contractors met on August 6, 2008 at the Professional Licensing Boards Division, 237 Coliseum Drive in Macon, Georgia, for the purpose of conducting Board business.

At 8:03 a.m., Chairperson Hopkins established that a quorum was present and called the meeting to order.

A motion was made by Roger Huggins, seconded by Timothy Ansley, and the Board voted unanimously to accept the July 9, 2008 full Board meeting minutes.

A motion was made by Morgan Wheeler, seconded by Timothy Ansley, and the Board voted unanimously to accept the July 16, 2008 Specialty Contractor Committee Conference Call minutes.

A motion was made by Bob Barnard, seconded by Mark Herbert, and the Board voted unanimously to accept the July 30, 2008 Residential Division Committee Meeting minutes.

There were no old business items to discuss.

There were no new business items to discuss.

Scarlett Elliott, Board Attorney, delivered the Attorney General's Report.

Ms. Elliott presented six Consent Orders for acceptance by the Board. These orders had been drafted by Ms. Elliott at the Board's request, mailed to applicants Jason Andrew Thomas, Gilbert Tillman, Phillip Jason Flatt, Douglas Eugene Majors, Timothy Hand and Scott Alan Belanger, and returned to Ms. Elliott signed by the applicants. The Consent Orders for these applicants allow them to be licensed under probationary terms.

At the July 9, 2008 meeting, Lisa Durden discussed a letter she received from Doug Hansford, Director of Athens-Clarke County Building Inspection Department. The letter asked whether employees of local government who perform renovation work to county owned buildings and facilities need to hold a General Contractors license. Ms. Elliott was asked to research this issue and report back to the Board. Ms. Elliott stated that she did not see an exception that fit what they had described, but if they come up with a provision that will exempt them, they can write to the board for clarification.

Tanja Battle delivered the Executive Director's Report.

Ms. Battle discussed the budget. Ms. Battle stated that the Board members were sent an e-mail from Randall Vaughn, Director of the Professional Licensing Boards (PLB). The Secretary of State has been asked to cut the budget by 6 to 8%. Travel is one of the areas that will be cut. Ms. Battle stated that one of our Board members has already asked that the State hold his check for mileage reimbursement. Ms. Battle stated that this was not the request of the agency and that she appreciated the offer to not claim mileage. Ms. Battle asked the Board if anyone was interested in using a laptop instead of receiving handouts for future board meetings to let her know as that can be arranged.

Ms. Battle discussed the business/law portion of the exam. At the July meeting it was said that if an applicant failed the examination twice, the applicant could apply to take the examination for a different license type. Ms. Battle stated that PSI had given the Board some conflicting information. If the applicant passes the business/law portion and fails the technical portion twice, the applicant can change license types; however, if the applicant fails the business/law portion, the applicant cannot retest because it is the same examination for all levels.

Ms. Battle stated that the Board does not have to proceed with the Failure to Maintain General Liability Insurance rule as previously discussed at the July 9, 2008 meeting. O.C.G.A. § 43-41-6(e) reads, in part: "...Additionally, all applicants shall provide proof of general liability insurance and of workers' compensation insurance as required by the laws of this state in their name. However, if and to the extent the applicant is submitted as a person seeking to act as a qualifying agent of a particular business organization, such proofs and information shall relate and pertain to such business organization rather than the individual applicant, subject to the limitations set forth in subsection (d) of Code Section 43-41-9. All applicants shall also provide their social security numbers, if applying as an individual, or the federal taxpayer identification numbers of any business organization for which the applicant is seeking licensure as a qualifying agent. Applicants for a general contractor's license shall also provide suitable verification of tax payments in a form and manner and for the duration prescribed by the general contractor division; provided, however, that where the application is seeking license as a qualifying agent of a business organization, such tax verification and information shall relate and pertain to that business organization. The decision of the appropriate division as to the qualifications of applicants shall, in the absence of fraud, be conclusive. A certificate by the insurer or other appropriate evidence of such coverages shall be maintained with the appropriate division and shall be a condition of renewal."

Ms. Battle discussed the "continuous" language mentioned in O.C.G.A. § 43-41-6(a)(2). She stated that Mrs. Durden is currently working on a rule regarding this. Mrs. Durden referred the Board to a handout regarding Proposed Rule Changes in Status Which Must Be Reported.

“Continuously” should be considered as 30 days. Ms. Battle asked the Board if they were comfortable with 30 days. Morgan Wheeler asked if there was a downside to giving more time such as 60 to 90 days.

Discussion ensued.

Ms. Battle stated that the Board does not have to vote to post this rule today. She stated that the Board can take their time reviewing it and it can be brought back for discussion at next month’s meeting. Chairperson Hopkins stated that this item will be tabled for further discussion.

Ms. Battle discussed a letter she received from Eddie H. Hensley regarding a request to appear before the Board. Mr. Hensley did not submit an examination exemption application before the July 1, 2007 deadline. Board staff has written a letter to him explaining to him that he does not have the right to an appearance. Ms. Battle asked the Board if they would like to see him or if another letter needs to be sent to him explaining that the Board does not have any leeway in making exceptions. The Board members agreed that another letter should be sent to Mr. Hensley explaining this.

Ms. Battle referred the Board members to a copy of a draft letter that she has been working on regarding multiple qualifying agent licenses for a business organization. She has sent a copy of the letter to Roger Huggins, Chairperson Hopkins and Ms. Elliott for their review. Ms. Battle presented two draft versions of the letter for the Board to review.

Mr. Wheeler asked why the Board was discussing this. He stated that the Board needed to move on. Mr. Huggins stated that the Board voted at the July meeting to have staff send a letter to all business organizations with three or more qualifying agents, and to all qualifying agents representing three or more firms. Bob Barnard stated that Mr. Wheeler had voted against this. Mr. Huggins stated that the Board voted on this to simply give people the opportunity to say they misunderstood what they were signing.

Discussion ensued.

A motion was made by Roger Huggins, seconded by Bob Barnard, to accept the letter that Ms. Battle presented to the Board. Chairperson Hopkins asked the Board if there was any discussion. David Cyr stated that the letter reads, “If all of your qualifying agents meet this requirement, no action is necessary”. Mr. Cyr stated that the letter does not state what the “action” will be. Ms. Battle stated that she would add what the action would be to the letter. The Board voted, with the exception of Morgan Wheeler, who opposed the motion, to accept the letter and have Board staff send out to all business organizations with three or more qualifying agents. The number of qualifying agents representing three or more companies was minimal and most were affiliated by ownership.

Complaints were discussed. Ms. Battle stated that the Board office is receiving complaints steadily. She asked what the Board’s position is on activities before July 1, 2008. The Board members stated that if it was practice related that it would be dismissed. Roger Huggins stated if the issue was criminal/fraudulent then he would like to pursue. Mark Herbert stated that he has reviewed a lot of complaints where the issue took place years ago. He feels that if the issue is

legitimate, he will forward to Investigations. Chairperson Hopkins stated that the complaints will need to be reviewed on a case by case basis.

Ms. Battle asked the Board if they would like to set up a committee to review the complaints. She stated that the Board office has been receiving complaints on unlicensed practice and would need to determine how to move forward with such while being consistent between the two divisions. Ms. Elliott stated that other boards use C&D's for unlicensed practice.

Roger Huggins made a motion to give the person 120 days to get licensed or a C&D would be issued. Mark Woodall, Associated General Contractors of Georgia, stated allowing such is a violation of the law. Bob Barnard stated that the Board has a lot of discretion as to what they can do in terms of violations. Ms. Battle stated that she believed there was language in the code that reads, "may" in regard to the Board's action against unlicensed practice. Ms. Elliott pointed out that a person may not sign the voluntary C&D, just as information.

Discussion ensued.

Chairperson Hopkins stated that he will appoint a committee between now and the next board meeting to handle complaints. He will appoint three members from each division.

Mrs. Durden discussed a handout regarding Tips for Consumers. She stated that Secretary of State Karen Handel suggested the Board have a link for tips. Mrs. Durden stated she would like to get the Board to review this.

Mrs. Durden discussed rule revisions. Last month the Board agreed to post Rule 553-9-02 Written Warranty for General Contractor. However, this rule was not posted and Ms. Elliott made a suggestive change. This rule mirrors the rule for the Residential Division.

A motion was made by Morgan Wheeler, seconded by Roger Huggins, and the Board voted unanimously to post Rule 553-7-.02, Written Warranty for General Contractor.

Committee Reports were discussed.

Bob Barnard, Specialty Contractor Committee, stated that handouts # 6, 7, 8, 9 and 10 would be referred to the Specialty Contractor Committee for discussion at their next meeting.

Mr. Barnard referred the Board to a handout regarding Residential Kitchen and Bath Designers/Installers. Mr. Barnard stated that the Committee along with Kevin Veler moved to adopt this as a specialty.

A motion was made by Mark Herbert, seconded by Steve Cash, and the Board voted unanimously to add "Residential Kitchen and Bath Designers/Installers" to the Specialty Contractors listing located on the Secretary of State website.

The Reciprocity Committee had nothing to report at this time.

Ms. Battle stated that a hearing regarding Rule 553-10-.01 Inactive License, would be held at the Board's next meeting scheduled for September 3, 2008.

The Board stated that the Building Official Notification/Pre-Licensing Affidavit Committee, Written Warranty Committee and the General Contractor Tier Committee would be deemed closed.

A motion was made by Timothy Ansley, seconded by Bob Barnard, and the Board voted unanimously to accept the six consent orders presented by Ms. Elliott earlier in the meeting.

A motion was made by Roger Huggins, seconded by Edward Strain, and the Board members present: Hoppy Hopkins, Philip Thayer, Timothy Ansley, Bob Barnard, Steve Cash, Dan Cash, David Cyr, Mark Herbert, Roger Huggins, Allen Richardson, Edward Strain and Morgan Wheeler, voted unanimously to enter into Executive Session for applicant appearances and application discussion.

Open Session was declared by the Residential Division.

Ms. Battle stated she received a phone call from Capitol Indemnity Corp/Platte River Insurance regarding some of the language that is not on the Surety Bond. They are stating that they would have a problem writing the bond form required for Residential and General Contractors as it is now written, as it does not contain customary and usual aggregate and cancellation clauses such as:

*Aggregate Clause: REGARDLESS of the number of claims or claimants or the number of years the bond remains in force or is renewed, the total aggregate liability of the surety for any and all claims will in no event exceed the penal sum of the bond.*

*Cancellation Clause: PROVIDED FURTHER, that the Surety may cancel this bond by giving 30 days written notice by Certified Mail to the Georgia State Board for Residential and General Contractors provided such cancellation shall not release any liability existing hereunder at the time of the effective date of said cancellation.*

Ms. Battle stated that she feels this would be hard for the Board to administer. Vice-Chairperson Thayer stated he would like to defer this matter to the Attorney General's office for their recommendations.

A motion was made by Mark Herbert, seconded by Allen Richardson, and the Residential Division voted unanimously to refer the issue of the Surety Bond not containing customary and usual aggregate and cancellation clauses to the Attorney General's office for their recommendations.

Bob Barnard discussed REIA (Real Estate Investment Association) and apartment maintenance. Mr. Barnard stated that REIA members are basically flippers. REIA informed Mr. Barnard that they do not pull permits. What they do is buy distressed properties, put them up for sale, put additions on, raise ceilings and they do not pull permits for this. Their investors will fix up the property and flip it or they will convert it into a rental property. Mr. Barnard stated that technically when they start coordinating subcontractors, they need to be licensed. Mr. Barnard asked if this matter should be deferred to the Specialty Contractor Committee. Vice-Chairperson Thayer stated that REIA should not be singled out. He stated that the Board needed to address the type of work they do, instead of REIA only. Vice-Chairperson Thayer stated the Specialty

Contractor Committee could come up with a letter of guidance to send. Ms. Battle stated that she felt the Board should not give legal advice.

Discussion ensued.

Vice-Chairperson Thayer stated that the Specialty Contractor Committee should review, make a recommendation and report back to the Board.

A motion was made by Bob Barnard, seconded by Mark Herbert, and the Residential Division voted unanimously to enter into Executive Session for applicant appearances and application discussion.

Open Session was declared by the Residential Division.
