At 8:19 a.m., Vice Chairperson Thayer established that a quorum was present and called the meeting to order.

A motion was made by Allen Richardson, seconded by Edward Strain, and the Board voted unanimously to accept the September 3, 2008 full Board meeting minutes.

There were no old business items to discuss.

New business items were discussed.

A motion was made by Allen Richardson, seconded by Morgan Wheeler, and the Board voted unanimously to set the calendar for the following 2009 meeting dates:

Scarlett Elliott, Board Attorney, delivered the Attorney General's Report.

Ms. Elliott presented five Consent Orders for acceptance by the Board. These orders had been drafted by Ms. Elliott at the Board's request, mailed to applicants Lawrence Wesley Hughes, Ronald S. Hunt, Frank F. Lewis, Jr., Wayne Thomas Holmes and George Raymond Hunter, Sr.,

and returned to Ms. Elliott signed by the applicants. The Consent Orders for these applicants allow them to be licensed under probationary terms.

Tanja Battle, Executive Director, delivered the Executive Director's Report.

Ms. Battle stated that this has been a very difficult time at the Professional Licensing Boards as restructuring resulted in the loss of staff. Because of the restructuring, there are now seven executive directors instead of ten with most taking on additional boards. She stated that Lisa Durden is now with the Cosmetology Board, but will be able to help out with the Residential/General Contractor meetings when Divisions separate for appearances.

Ms. Battle stated that because of the low number of applications needing review on the General Contractor side that conference calls may suffice to address issues by this division in the future. Board staff will monitor the work load and e-mail applications to the board members for review.

A motion was made by Roger Huggins, seconded by Morgan Wheeler, and the Board voted unanimously to allow board staff to administratively approve General Contractor Prior Approval applications where there is no question of the qualifying agent's authority in the business entity. If the qualifying agent is affiliated as owner or a corporate officer, the affiliation will be clear. Ms. Battle added that if there is any question regarding the affiliation, staff can scan the application and e-mail it to a board member for review.

Ms. Battle shared a letter she received from an applicant requesting to take the examination for a third time due to his disability. Ms. Battle stated that there is no exception in the law due to physical hardship. The Board lacks any leeway in making an exception and allowing someone to sit for a third time.

Ms. Battle stated that she has discussed with several board members the fact that an applicant is only allowed to take the examination twice within one year. She asked the Board members if they are comfortable with that limitation. Other boards have similar limitations while others do not. Some boards require specific education requirements that must be completed prior to being allowed to sit for re-examination.

Discussed ensued.

Vice Chairperson Thayer recommended tabling the issue at this time.

Ms. Battle shared with the board two letters she received in response to the QA letters that were sent out in August.

Ms. Battle stated that the Board has invited a company that has 40 active qualifying agents to come in and speak.

Ms. Battle stated that she has been receiving many calls from counties regarding whether or not licensure is required for specific projects. She has been referring them to their local attorneys for legal advice.

A letter from Dekalb County Purchasing and Contracting was discussed. Dekalb County is asking that a representative from the board come and speak to them. Ms. Battle stated that all speaking engagements were being denied due to budget constraints and a directive from the Governor's Office to curtail all non-essential travel.

Ms. Battle stated that as board staff approves Prior Approval applications, they are only doing so for license types at the same level. Will the Board allow the applicant applying via Prior Approval to go from one license type to the other?

A motion was made by Roger Huggins, seconded by Timothy Ansley, and the Board voted unanimously to allow the applicant applying via Prior Approval to move from one license type down to another.

Ms. Battle asked Ms. Elliott if there was an issue with doing such. Ms. Elliott advised that she would look into it.

A motion was made by Steve Cash, seconded by Morgan Wheeler, and the Board voted unanimously to accept the five consent orders presented by Ms. Elliott earlier in the meeting.

Committee Reports were discussed.

Handouts #1 and #2 will be referred to the Specialty Contractor Committee for discussion at their next meeting.

Reciprocity Committee had nothing to report at this time.

Ms. Battle added that she will have a draft of a reciprocity rule prepared for the next meeting, as well as a reinstatement application.

Ms. Battle further stated that she would have the Application for Inactive Status posted online as soon as possible. Ms. Battle asked regarding the fee to change a status from Active to Inactive. The Board directed Ms. Battle to research what other boards charged for such and appropriately align the fee.

The Qualifying Agent Committee had nothing to report at this time.
