Board Meeting: November 5, 2008

At 8:02 a.m. Chairperson Hopkins established that a quorum was present and called the meeting to order.

Approval of Minutes

Chairperson Hopkins asked for any additions or deletions to the October 1, 2008 full Board meeting minutes. A motion was made by Roger Huggins, seconded by Timothy Ansley, and the Board voted unanimously to accept the minutes as presented.

Old/New Business

Revoked Licenses/Pocket Cards: Ms. Battle relayed that she had spoken with Mr. Huggins concerning the request for licensees to return their pocket cards when their licenses are revoked. Mr. Huggins wanted to have further discussion with the Board regarding this topic. Mr. Barnard asked can the building permit offices take it. Mr. Wheeler responded by stating that by looking the licensee up in the computer, one will be able to tell if the license has been suspended. Ms. Battle stated that the license is merely a snapshot of the status at the time it is printed. Ms. Battle reiterated the importance of local permitting offices utilizing the online verification available through the Secretary of State's website.

Board Meeting: November 5, 2008

Specialty Projects: Ms. Battle stated that there was discussion at the March 26, 2008 board meeting concerning specialty projects and whether or not they would suffice to meet the requirement for licensure by examination. This topic came up again at the June 4, 2008 board meeting and the General Division expressed uncertainty about accepting specialty projects. Ms. Battle stated that she needs clarification from the Board on how to proceed so that she can communicate with board staff regarding the processing of the exam applications.

Discussion ensued.

Mr. Huggins asked Chairman Hopkins to appoint a committee so that they can set up guidelines for the Division to set a rule by. Ms. Battle asked for direction on how to proceed with processing these applications until the committee established guidelines.

After further discussion, it was decided that if there is any question concerning the projects that the application will go to a board member for review before proceeding with it. Mr. Huggins, Mr. Wheeler, Mr. Cyr and Mr. Ansley volunteered to serve on the committee.

A motion was made by Tommy Holder, seconded by Morgan Wheeler, and the Board voted unanimously to have board staff submit any General Contractor exam applications with specialty projects to Mr. Huggins for review.

Cognizant Member for Residential Division: A motion was made by Bob Barnard, seconded by Morgan Wheeler, and the Board voted unanimously to elect Steve Cash as an additional Cognizant Member for the Residential Division.

Qualifying Agent Leaving a Business Organization: A motion was made by Bob Barnard, seconded by Steve Cash, and the Board voted unanimously to make it a policy that a qualifying agent who leaves a business organization has 120 days to submit a prior approval application as a qualifying agent for another business organization or as an individual. This will run concurrent to the 45 days given to the business organization and the qualifying agent notifying the board that the qualifying agent has left the business organization. The above was voted on at the September 3, 2008 meeting as a modification to Proposed Rule 553-11 Changes in Status Which Must Be Reported.

Written Correspondence

Surety Bonds: Ms. Battle received an e-mail from an insurance company that is currently working on a bond for someone that is applying for licensure as a contractor. If this person applies with a bond (because they cannot provide proof of having an account open for 24 months) and the applicant is licensed, can the licensee drop the bond if they are able to obtain the proof of having an account open for 24 months? Ms. Battle asked how the board would like to handle this. A motion was made by Bob Barnard, seconded by Morgan Wheeler, and the Board voted unanimously to state that the bond needs to continue until the renewal period, but after the renewal period, the bond can be dropped if the licensee can provide appropriate documentation, but only at the request of the licensee.

Letter of Credit Requirement: Ms. Battle has received numerous phone calls from applicants stating that, due to the economy, banks often will not issue a line of credit. Ms. Battle asked the Board if it would like to consider an alternative to this requirement. Mr. Holder asked if the Board can handle this by exception. Ms. Battle responded by stating it is in the rules, so it would be a rule amendment. Mr. Huggins asked Ms. Battle to put this matter on the list for potential legislative changes.

A motion was made by Roger Huggins to release the line of credit as a requirement for the General Contractor Limited Tier. Ms. Battle stated that it is in the rules. The motion was withdrawn by Mr. Huggins.

Attorney General's Report

Ms. Elliott delivered the Attorney General's Report. Ms. Elliott presented six Consent Orders for acceptance by the Board. These orders had been drafted by Ms. Elliott at the Board's request, mailed to applicants David Michael McCay, David T. Doerr, John Wesley Phillips, Carl John Raimondi, Richard Gordon Fueston and Terry Lee Fernander, and returned to Ms. Elliott signed by the applicants. The Consent Orders for these applicants allow them to be licensed under probationary terms.

A motion was made by Bob Barnard, seconded by David Cyr, and the Board voted unanimously to accept the consent orders.

Executive Director's Report

Ms. Battle stated that, with the restructuring, the focus of the agency is on three areas: applications, complaints and compliance. Ms. Battle stated that the agency is committed to supporting the Board as it carries out its functions. Additionally, tasks that do not fall within these three areas will need to be assessed in terms of available resources.

Inactive Status Applications: The board office has received eight applications for Inactive Status since they have been made available.

Prior Approval Applications: At the October 1, 2008 meeting the Board voted to allow an applicant applying by Prior Approval to move from one license type to another. Ms. Battle stated that Ms. Elliott pointed out that the law does not support this. Ms. Elliott stated that she could not find language in the law that would allow a General Contractor to apply for a Residential Basic or Residential-Light Commercial license by prior approval. Discussion ensued. Mr. Huggins asked Ms. Battle to put this matter on the list for potential legislative changes.

Line of Credit-Investment Company vs. Banking Institution: Ms. Battle asked if the Board would accept a line of credit from an investment company. Mr. Thayer had some questions on how to know if the investment company is solvent. Mr. Ansley stated that when reviewing applications he has seen lines of credit from investment companies that have been approved. Discussion ensued.

A motion was made by Bob Barnard, seconded by Morgan Wheeler, and the Board voted unanimously to accept the line of credit from investment companies.

Open Records Requests: Three Open Records Requests were submitted by C. Dean Gunnells, Senior Paralegal, regarding G.S., B.S.N., and B.S.N.H. A motion was made by Bob Barnard, seconded by David Cyr, and the Board voted unanimously to deny the open records requests.

Reactivation Applications: Ms. Battle discussed reactivation applications for General Contractor Limited Tier, General Contractor, Residential-Light Commercial Contractor and Residential Basic Contractor with a \$200 reactivation fee. A motion was made by Timothy Ansley, seconded by Tommy Holder, and the Board voted unanimously to approve the applications and fee amount.

Committee Reports

Specialty Contractor: Mr. Barnard, Chairman of the Specialty Contractor Committee, discussed correspondence received from the following:

- *Ultraflote Corporation:* Mr. Barnard stated that this company is a roofing type contractor. The company manufactures geodesic domes, flat panels and internal floating roofs. A motion was made by Roger Huggins, seconded by Bob Barnard, and the Board voted unanimously to make this a limited service specialty with the stipulation that the company proposes a generic name for this to be listed under on the website.
- *ISS Integrated Storage Solutions:* A motion was made by Bob Barnard, seconded by Tommy Holder, and the Board voted unanimously to add Racking Systems as a Limited Service Specialty to the Secretary of State website.
- *MEGTEC Systems, Inc.:* A motion was made by Bob Barnard, seconded by Morgan Wheeler, and the Board voted unanimously to ask the company to provide the committee with a generic name and list what the scope of their work entails.

Reciprocity: Mr. Holder, Chairman of the Reciprocity Committee, stated he had spoken with Ms. Battle in reference to reciprocity. Ms. Battle stated that she sent an e-mail, thru a distribution list from NASCLA, to the other states to determine interest in a reciprocal agreement with Georgia. She has only received five responses. Tennessee has responded with interest and relayed that it would extend reciprocity to those who were licensed by examination exemption. Discussion ensued. Mr. Huggins, Mr. Holder and Chairperson Hopkins agreed that the Board does have other items to work out before finalizing reciprocity.

Qualifying Agent: Mr. Huggins, Chairman of the Qualifying Agent Committee, stated that there have been responses to the letter that was sent out in August. Mr. Huggins feels that this committee can be dissolved at this time.

Chairperson Hopkins stated that he will work on appointing a committee for Continuing Education.
