Ms. Battle stated that she has responded to Ms. Whitaker and stated that it is not policy, nor the practice of the Board, to grant an appearance to someone who has not submitted an application. Only someone who has an application that has been denied has the *right* to appear before the Board; however, it is up to the Board. A motion was made by Bob Barnard, seconded by Philip Thayer, and the Board voted unanimously to deny her request to appear before the Board.

Old/New Business

Board Rules: A motion was made by Bob Barnard, seconded by Mark Herbert, and the Board voted unanimously to post Rule 553-12-.01 License Renewal, Rule 553-12-.02 Continuing Education, Rule 553-12-.03 Programs Which Qualify, and Rule 553-12-.04 Controls and Reporting.

A motion was made by Allen Richardson, seconded by Philip Thayer, and the Board voted unanimously that the formulation and adoption of this amendment does not impose excessive regulatory cost on any licensee and any cost to comply with the proposed rule cannot be reduced by a less expensive alternative that fully accomplishes the objectives of O.C.G.A § 43-41-5(b).

A motion was made by Allen Richardson, seconded by Philip Thayer, and the Board voted unanimously that it is not legal or feasible to meet the objectives of O.C.G.A § 43-41-5(b) to adopt or implement differing actions for businesses as listed at O.C.G.A. § 50-13-4(a)(3)(A), (B), (C) and (D). The formulation and adoption of these rules will impact every licensee in the same manner and each licensee is independently licensed, owned and operated and dominant in the field of residential contracting.
