At 9:00 a.m. Chairperson Barnard established that a quorum was present and called the meeting to order.

Approval of Minutes

A motion was made by Allen Richardson, seconded by Mark Herbert, and the Board voted unanimously to approve the minutes of the June 3, 2009 full Board meeting as presented.

A motion was made by Allen Richardson, seconded by Mark Herbert, and the Board voted unanimously to approve the minutes of the June 15, 2009 full Board Conference Call as presented.

A motion was made by Mark Herbert, seconded by Morgan Wheeler, and the Board voted unanimously to approve the minutes of the Residential Division Continuing Education and Renewal Committee Conference Call as presented.

Old/New Business

Mark Woodall, Associated General Contractors of Georgia: Mr. Woodall spoke to the Board concerning a panel discussion with a group in Rome concerning the licensing law. Mr. Woodall stated that it ended up being a very positive event. He further stated that the group has an interest in

a number of legislative changes. Specifically, financial requirements and obligations. Mr. Huggins suggested this group come up with guidelines and work with a subcommittee of this Board. Chairperson Barnard stated that the Board could have a policy manual to give to each jurisdiction. Discussion ensued.

Executive Director's Report

Consent Orders: A motion was made by Allen Richardson, seconded by Mark Herbert, and the Board voted unanimously to make it a policy to accept all Consent Orders for Licensure, where no terms have been changed, upon receipt in the Board office and authorize the president/chairperson or his or her designee to execute the Order and to authorize the Orders to be docketed and served. It is the intent of the Board that the Orders will be signed by the Executive Director, Tanja Battle, and will be in effect upon docketing. The State Licensing Board for Residential and General Contractors will ratify the docketed Consent Orders for Licensure at its next meeting after the date of docketing and include a list of the approved orders in the board minutes.

Board Rules: A motion was made by David Cyr, seconded by Mark Herbert, and the Board voted unanimously to post Rule 553-9-.01 Grounds for Disciplinary Action and Rule 553-9-.02 Disciplinary Actions.

GA Connector Taxiway and Site Development Project: Ms. Battle discussed a letter she received requesting the Board's opinion as to whether a general contractor performing the referenced taxiway and site development project must obtain a general contractor's license. Ms. Battle stated that she responded by stating that the Board does not give legal advice for specific projects. The Board concurred with Ms. Battle's response.

Harris County Building Permits: Ms. Battle stated she received an e-mail from Harris County regarding a question they have concerning a developer of a subdivision who owns the lots that wants to hire a licensed contractor to build houses on the lots. This person states that the developer will sell the lots and the houses, as opposed to the builder. Discussion ensued. A motion was made by Allen Richardson, seconded by David Cyr, and the Board voted, with the exception of Morgan Wheeler, who opposed the motion, to have staff send a response to Harris County stating that the Board is not aware of a code section that prohibits the actions presented in the email and to request that they send the Board the code section that they believe addresses this situation.

Applicant W.L.J.: A motion was made by Mark Herbert, seconded by Edward Strain, and the Board voted unanimously to deny the residential-light commercial application for licensure by prior approval and the general contractor application for licensure by examination of applicant W.L.J.

Board Meetings: Ms. Battle asked the Board to consider conducting business via conference call unless there were appearances and hearings scheduled. Chairperson Barnard responded by stating that, with the current economy the way it is, the Board should conduct business via conference call whenever possible. He further stated that the Board will only meet as necessary. Mr. Huggins stated that the full Board is only required to meet twice a year and the two Divisions are required to meet six times a year. The Board further stated that it will not hold its monthly meeting in September. The Board will meet again in October.

Other Business

Mr. Huggins stated he had several items he would like to discuss. He has been hearing many pleas for relief regarding the financial requirements for licensure. He stated that this issue could be discussed when the General Contractor Division meets following the full Board meeting.

Mr. Huggins discussed possible rules on advertising. He stated that the Board needs to get rules in place concerning licenses being posted on business cards, automobiles, etc., so that the consumer is very aware of what license is held. Ms. Elliott stated the Board's laws prohibit someone from falsely representing himself as or advertising as a residential or general contractor, but they do not require licensees to post certain information on business cards or vehicles. The Board has the authority to establish policies and procedures for regulating residential and general contractors and to promulgate rules necessary to carry out their laws. Kevin Veler, Legal Counsel for Business and Construction, stated that many people are driving around advertising as being licensed/insured on their vehicles when their license is an occupational business license. Chairperson Barnard emphasized that a person who does not hold a state license for the practice of residential or general contracting may not advertise such on his or her vehicle.

Mr. Huggins discussed the Qualifying Agent Affidavit. Mr. Huggins stated that this problem still exists. Also, he pointed out that the Board has not voted on a policy as to governmental entities performing their own work. Mr. Huggins asked if the General Contractor Division wanted to consider this subject on its own. Ms. Battle responded by stating that the Board does not have any flexibility on this issue because the law clearly states what responsibilities a qualifying agent must have in a company. Ms. Elliott reiterated that the qualifying agent issue would have to be a legislative change. Discussion ensued.

Committee Reports

Specialty Contractor Committee: Mr. Barnard, Chairman of the Specialty Contractor Committee, discussed the following:

- *Proposal to modify Limited Specialty Category "Remediation"* (tabled from June mtg): Mr. Huggins stated the Committee will leave the category as written.
- *Request from NewSolergy to have "Renewable Energy" added as a Specialty* (tabled from June mtg): The Board recommended to not include these services as a Specialty Contractor.
- *Correspondence regarding fire sprinkler installation:* The Board recommended referring this person to O.C.G.A. § 43-41-17, which lists all the exceptions to the requirements for licensure.
- *Bridge Builders, USA:* The Board recommended referring this person to O.C.G.A. § 43-41-17, which lists all the exceptions to the requirements for licensure.
- *Modular Solutions, Inc.:* The Board recommended not taking any action at this time.
- *Wear Tek, Inc.:* The Board recommended referring this person to O.C.G.A. § 43-41-17, which lists all the exceptions to the requirements for licensure.
- *SolarTEK Energy of Georgia:* The Board recommended to not include these services as a Specialty Contractor.
- *K&G Industrial Services, LLC:* The Board recommended referring this person to O.C.G.A. § 43-41-17, which lists all the exceptions to the requirements for licensure.

Correspondence from Paula Pate, United Commercial Construction: Ms. Battle presented Ms. Pate's recommendations concerning unemployment in the Georgia construction industry.

Correspondence from Johnny Reichert, Director of Building, Planning & Zoning-Thomas County: Ms. Battle discussed Mr. Reichert's letter to the Board concerning contractors who have filed for bankruptcy after having obtained the license. The Board recommended having staff respond by stating that at this juncture, the Board has no authority to discipline a licensee who files for bankruptcy after having obtained the license. The Board is currently working on rules and hopes to address financial responsibility during the renewal cycle.

Correspondence from Glen Palmer, Foley Construction Corporation: Ms. Battle presented Mr. Palmer's letter to the Board. The Board did not offer any interpretations, clarifications or statements at this time.
