A motion was made by Roger Huggins, seconded by Mark Herbert and the board voted unanimously to administratively issue a letter to prior approval applicants for which licensure was initially granted based on inaccurate information, advising such that they can pursue licensure via examination.

Morgan Wheeler motioned, Mark Herbert seconded and the Board also voted that it is not legal or feasible to meet the objectives of the applicable laws to adopt or implement differing actions for businesses as listed in O.C.G.A. §50-13-4(3)(A)(B)(C)(D). The formulation and adoption of these rules will impact every licensee in the same manner and each licensee is independently licensed, owned and operated in the field of Residential and General Contractors.
