NASCLA Examination:

Tanja Battle had been in discussions with PSI, following their request to clarify if the Board intended to require the NASCLA examination in lieu of or in addition to the current State General Contractor license examination. The Board confirmed the NASCLA examination will be required in lieu of the State examination.

Residential Clubhouses:

The Board discussed an informal request regarding licensure requirements to build a clubhouse, and agreed that licensure requirement would depend on occupancy and that an appropriate response to this inquiry would be to refer someone to the definitions in the law along with the code section that addresses life safety code.

Committee Reports

Specialty Contractor Committee:

Further to discussions at the last meeting about refractory work being added to the Specialty List, members agreed to define it as “refractory maintenance and repair”.

The Board discussed a letter from a legal firm seeking clarification for a client on the scope of re-roofing work. The Board requested that a response be sent advising ~~that the client be advised~~ to refer to the relevant sections of law.
