Old/New Business

NASCLA Examination

Tanja Battle informed members that since the last meeting, she has communicated with NASCLA and several other states regarding reciprocal arrangements. NASCLA had previously offered to assist with reciprocity with other states. Ms. Battle stated she would contact NASCLA prior to the next meeting.

A motion was made by David Moody, seconded by Gene Dunwody, and members voted unanimously to accept NASCLA examination scores from any state where the national examination is taken. In the same motion, members agreed that the applicant will still be required to pass the state portion, and meet other Georgia licensing requirements.

Roger Huggins will lead a Reciprocity Committee, and will investigate options to establish reciprocity processes in anticipation of rule 553-2-.13 becoming effective.

Petitions for Rule Waiver or Variance

Members considered a Petition for Rule Waiver submitted by Mr. Robert D. Rizzo. A motion was made by Morgan Wheeler, seconded by Aaron McWhorter, and members unanimously voted to request further documentation regarding the time Mr. Rizzo was out of the country. Upon acceptance of the documents, the petition will be granted.
