Dr. Roberts-Betsch called the meeting to order at 9:05 a.m. A quorum to conduct disciplinary matters was determined to exist.

PROGRAM APPROVALS

Armstrong Atlantic State University

The approval status for Armstrong Atlantic State University was reviewed. Full Approval could be extended through December 31, 2006 with a site visit conducted during the 2005-2006 academic year. Recommendation of the subcommittee:

Based upon review and documentation of compliance with rules relating to annual reports, the most recent site visit report and response, and an average passing percentage of at least 80% (170/205, 82.9) of all first-time writers of the NCLEX-RN over the last four years (2000-2003), **Full Approval** is extended from December 31, 2004 to December 31, 2006 [410-3-.02 (3)(a)]. Unless another reason presents itself, the next site visit will be scheduled during the 2005-2006 academic year [410-.01 (d)].

Brenau University

For the last three years (2001, 2002, 2003), Brenau University has met the requirements that at least 80% of its first-time writers pass the NCLEX-RN. It would seem reasonable to grant **Full Approval** to Brenau University through March 31, 2005 [410-3-.02 (3)(c)]. This would allow review in another year. If the overall four-year passing percentage is at least 80% the Board could consider extending the Full Approval. Recommendation of the subcommittee:

Based upon compliance with 410-3-.08 in 2001, 2002, and 2003, **Full Approval** is granted to the baccalaureate-nursing program at Brenau University through March 31, 2005 [410-3-.02 (3)(c)].

Georgia Perimeter College

At its March 14-16, 2001 meeting the Board imposed Conditional Approval on the program due to noncompliance with 410-3-.02 (3). The last site visit was conducted on March 25-26, 2002. The program is eligible for Full Approval through December 31, 2006, which will maintain its four-year site visit schedule. Recommendation of the subcommittee:

Based upon review and documentation of compliance with rules relating to annual reports, the most recent site visit report and response, and an average passing percentage of at least 80% (277/330, 83.9) of all first-time writers of the NCLEX-RN over the last four years (2000-2003), **Full Approval** is extended through December 31, 2006 [410-3-.02 (3)(a)]. If no other reason presents itself, the next site visit will be scheduled during the 2005-2006 academic year [410-.01 (d)].

Georgia Southern University

At its March 27-28, 2003 Board meeting, the Board of Nursing reviewed the approval status of the baccalaureate nursing program. In 2003, 78.6% (48/61) of first-time NCLEX-RN writers had passed. The four-year average is 81.4% (193/237). In January and February 2004, 35/37 first-time writers passed. A routine site visit has been scheduled for September 15-16, 2004. Recommendation of the subcommittee:

Based upon a passing percentage of first-time NCLEX-RN writers of less than 80% in 2003 [78.6% (48/61)], but with a four-year average (2000-2003) of at least 80% (81.4%), the baccalaureate nursing program at Georgia Southern University must submit a written evaluation of the 2003 plan of action for review by the Board of Nursing at its May 19-21, 2004 meeting [410-3-.02 (3)(a)(2)].

Middle Georgia College

At its March 27-28, 2004 Board meeting, the Board reviewed the January 21-22, 2003 site visit report. In 2003, 74.0% (40/54) of first-time NCLEX-RN writers had passed. The four-year average is 80.6% (100/124). Recommendation of the subcommittee:

Based upon a passing percentage of first-time NCLEX-RN writers of less than 80% in 2003 [74.0% (40/54)], but with a four-year average (2000-2003) of at least 80% (80.6%), the associate degree nursing program at Middle Georgia College must submit a written evaluation of the 2003 plan of action for review by the Board of Nursing at its May 19-21, 2004 meeting [410-3-.02 (3)(a)(2)].

Valdosta State University

This program has Full Approval through December 31, 2004. A regular four-year visit is scheduled for April 26-27, 2004. Recommendation of the subcommittee:

Based upon a passing percentage of first-time NCLEX-RN writers of less than 80% in 2003 [67.3% (35/52)], but with a four-year average (2000-2003) of at least 80% (80.4%), the baccalaureate program at Valdosta State University must submit a written assessment, plan of action, and progress report for review by the Board of Nursing at its May 19-21, 2004 meeting [410-3-.02 (3)(a)(1)].

INTERNATIONAL LICENSURE ISSUES

The Board of Nursing reviewed the NCSBN News Release dated January 12, 2004: NCLEX for VISA Screen.

Mr. Thigpen moved that the Board of Nursing not support NCLEX-VISA Screen proposed by the NCSBN. Applicants must meet the requirements for licensure by Examination as outlined in the Board of Nursing Rules and Regulations 410-6-.02. Mrs. Stegall seconded the motion and it carried unanimously.

Comparison study of the NCLEX-RN and the Puerto Rican Exam:

NCSBN: Comparison study of the NCLEX-RN and the Spanish Language Puerto Rican Nurse Licensure Examinations. The Board discussed and supports the conclusion as founded by the NCSBN study as follows:

Because of the cited open issues and lack of data, NCSBN cannot provide currently a definitive assessment of whether the Puerto Rico examinations are substantially equivalent to the NCLEX-RN examination. However, information collected to date does not support a determination of equivalency between the NCLEX-RN and the Puerto Rico Board of Nursing Registered Nurse Licensure Examinations.
