A Meeting of the Georgia Board of Examiners of Licensed Practical Nurses was held on September 1, 2004 at 9:15 a.m. in Room 102 of the Office of the Secretary of State, Professional Licensing Boards, 237 Coliseum Drive, Macon Georgia.

President Taylor established that a quorum was present and called the Board meeting to order at 9:05 a.m.

Agenda: Ms. Mitchell moved, Ms. Shaw seconded, and the Board approved the Agenda as revised.

Minutes: Ms. Shaw moved and Ms. Dumas seconded and the Board approved the minutes from the July 7 & 8, 2004 Board meeting as written. Ms. Mitchell moved and Ms. Blackburn seconded and the Board approved the minutes from the August 17, 2004 Conference Call as written.

Ms. Shaw moved and Ms. Mitchell seconded and the Board voted to enter into Executive Session in accordance with O.C.G.A. §43-1-2(k)(1), (2) and (4); §43-1-19(h)(2), (3) and (4) and O.C.G.A. §43-1-19(h); 50-14-2(1) to deliberate on investigations and applications and receive information on application and investigative reports and the attorney general's report. Voting in favor of the motion were Ms. Taylor, Ms. Shaw, Ms. Mitchell, Ms. Blackburn and Ms. Dumas. The Board concluded executive session in order to vote on these matters and to continue with the public session.

Technical Certificate of Credit Programs through the Department of Technical Adult Education (DTAE):

The Board reviewed the course objectives for AHS103 and NSG110 and **Ms. Mitchell moved and Ms. Dumas seconded and the Board voted to inform the Department of Technical and Adult Education that certain objectives in AHS103 and NSG110 should include better role delineation and that NSG110 should be divided in to separate licensed objectives from non-licensed objectives.**

PROPOSED AMENDMENTS TO BOARD RULE 400-3-.07:

Rule Change: 400-2-.07 Renewal of License. Amended.

Ms. Shaw moved and Ms. Mitchell seconded and the Board voted to consider for adoption the proposed rule amendment during its November 4, 2004 meeting beginning at 9:35 a.m. at 237 Coliseum Drive, Macon, Georgia, 31217.

Ms. Dumas moved and Ms. Mitchell seconded and the Board voted to post the Notice of Intent to Adopt and Notice of Hearing for the proposed rule change to rules 400-2-.07 for no less than 30 days prior to November 4, 2004 when the Board will hold a hearing on the rule and intent to adopt the proposed rule change.

Ms. Blackburn moved and Ms. Shaw seconded and the Board voted that the formulation and adoption of Rules 400-2-.07 does not impose excessive regulatory cost on any licensee and any cost to comply with the proposed rule cannot be reduced by a less expensive alternative that fully accomplishes the objectives of Official Code of Georgia Annotated §§43-1-25; 43-5-6 and 43-5-8.

Ms. Mitchell moved and Ms. Dumas seconded and the Board voted that it is not legal or feasible to meet the objectives of O.C.G.A. §§43-1-25; 43-5-6 and 43-5-8 to adopt or implement differing actions for businesses listed at O.C.G.A. §50-13-43(3)(A) and that the formulation and adoption of Rule 400-2-.07 will impact every licensee in the same manner and each licensee is independently licensed, owned and operated in the field of licensed practice nurses:

(1) All licenses expire March 31st, of all odd years. Each licensed practical nurse shall make application for a renewal of license and pay required fees in U.S. Funds prior to the expiration of the license.

(2) Each license will expire and must be renewed by March 31st of odd numbered years. Licenses not renewed by March 31st of odd numbered years may be renewed by June 30th of that year by the payment of the current renewal fee, plus an additional late renewal fee. See fee schedule. Practicing with an expired license is prohibited by law, and practice during this period may result in disciplinary action for unlicensed practice.

(3) Failure to renew a license by June 30th following the March 31st expiration date shall have the same effect as revocation of a license. Such license shall be deemed to be administratively revoked and may be reinstated at the discretion of the Board. Practicing with an expired or administratively revoked license shall be prohibited by law, and practice during this period may result in disciplinary action for unlicensed practice.

(a) The holder of a license that has been administratively revoked shall be required to make application to the Board for reinstatement pursuant to Rule 400-2-.08 and pay the required fee. Reinstatement of a revoked license is at the sole discretion of the Board.

(b) The holder of a license that has been administratively revoked who continues employment as a licensed practical nurse without a valid license shall, upon substantiation thereof, be subject to disciplinary action as provided by Law and Rule 400-2-.09. Disciplinary sanctions may be imposed by the Board as a condition to reinstatement of a license.
