RNI060322 – Mrs. Keeton moved to refer to Legal Services for a Private Consent Agreement for Reinstatement to include a fine of \$50 for two months of unlicensed practice and completion of the following courses for practicing outside her scope of practice: Medication Errors: Detection and Prevention, Ethics of Nursing Practice and Professional Accountability and Legal Liability for Nurses to completed within 90 days. A temporary permit will be issued pursuant to the terms of the Consent Agreement and upon the applicant completing the terms of the Consent Agreement a permanent license will be issued. Mrs. Ayers seconded the motion and it carried unanimously.




REINSTATEMENT APPLICATION REVIEW
