the QMA pilot program. Following discussion, the Board voted to approve this second site in an effort to bolster interest in the program.

- The Board received a letter from S. Tyler interested in providing independent private duty nursing service. They would like to know are there any licensure, certifications, paperwork, or continuing education that is needed to start. The Board referred the author to O.C.G.A. § 43-26-32(7) for the code section regarding supervision of LPN's and to the Board rules.
- The Board received faxed correspondence from the Cobb County School District Nursing Supervisor regarding out of county, out of state and overnight field trips for diabetic students and the request by the district for the provision of nursing services on these trips. Can LPN's provide nursing services for these field trips? Following discussion, the Board stated an LPN may accompany the students as a "chaperone", but not as an LPN. Referred to O.C.G.A. § 43-26-37. For trips within the state of Georgia an LPN shall follow the Board's rules and conform to the scope of practice set forth in the practice act. Trips outside the boundaries of this state would fall under the jurisdiction of the laws and rules governing nursing practice in the state or jurisdiction.

OPEN MEETINGS ACT: (O.C.G.A. § § 50-14-1)

Janet Jackson, Board Attorney gave an overview to the Board regarding the Open Meeting Act:

The Open Meeting Act mandates how state and local government bodies conduct their business during the “open” session of a meeting. The public must be given proper notice so that anyone interested may attend. Ms. Jackson reviewed the “closed” or “executive” session of such meetings when confidential matters and legal advice is received by the Board.

- **Notice:** Prior to conducting any meeting, an agency must give proper notice of the time and place of the meeting
- **Agendas:** The agency must take an agenda of all matters expected to come before the board at such meeting
- **Summary:** Following the meeting, a summary of the agenda items acted on and the members present must be made available to the public.

OPEN RECORDS ACT: (O.C.G.A. §§ 50-18-70)

All public records of an agency are open with the exception of certain items identified in the law (i.e. disciplinary matters, applications, investigative reports...)

Definition of Public Record:

Public records include all “documents” received or maintained by a public office. The definition is very broad and includes all papers, letters, maps, photographs, and tapes. Public record may also include those records “received or maintained by a private person, firm, corporation, or other private entity in the performance of a service or function for or on behalf of an agency.
