Rowe called the meeting to order at 10:00 a.m. on Wednesday, September 9, 2015. A quorum to conduct disciplinary matters was present.

EXECUTIVE SESSION

Barton moved, Fletcher seconded and the Board voted to enter into **Executive Session** in accordance with O.C.G.A. §§ 43-1-2(k); 43-1-19(h), 43-26-5(c) and 43-26-11, to deliberate on applications and enforcement matters and to receive information on applications, investigative reports and pending cases. The motion passed unanimously.

At the conclusion of the Executive Session on Wednesday, September 9, 2015 Rowe declared the meeting to be “open” pursuant to the Open and Public Meeting Act, O.C.G.A. §§ 50-14-1 et seq. No votes were taken during executive session.

HEARING – Melissa Miller – Board Docket 2015-0875

LPN060326 – A hearing was held in the matter of Melissa Miller. The respondent did not attend the hearing.

EXECUTIVE SESSION

Shilling moved, Lockwood seconded and the Board voted to enter into **Executive Session** in accordance with O.C.G.A. §§ 43-1-2(k); 43-1-19(h), 43-26-5(c) and 43-26-11, to deliberate on evidence provided during the hearing. The motion passed unanimously.

At the conclusion of the Executive Session on Wednesday, September 9, 2015 Rowe declared the meeting to be “open” pursuant to the Open and Public Meeting Act, O.C.G.A. §§ 50-14-1 et seq. No votes were taken during executive session.

Barton moved to deny the renewal and revoke the license for noncompliance with the MPE order. Fort seconded the motion and it carried unanimously.

EXECUTIVE SESSION

Lockwood moved, Hooper seconded and the Board voted to enter into **Executive Session** in accordance with O.C.G.A. §§ 43-1-2(k); 43-1-19(h), 43-26-5(c) and 43-26-11, to deliberate on applications and enforcement matters and to receive information on applications, investigative reports and pending cases. The motion passed unanimously.

Rowe called the meeting to order at 8:30 a.m. on Thursday, September 10, 2015. A quorum to conduct disciplinary matters was present.

STRATEGIC PLAN

The Board reviewed and updated the 2014-2016 Strategic Plan. Board member assignments were updated to reflect the Board's current membership.

The Board reviewed the call center statistics for the calendar year to date. Board members noted the improvements since a dedicated call center unit was assigned to the Board of Nursing. Members discussed the need for a call center satisfaction survey to ensure that callers were receiving accurate and helpful information.

The Board discussed the need for Board input in the annual review process for the Board's executive director.

The Board discussed the lack of input into the budget process. Board members discussed the previous meeting with the Governor's Office of Planning and Budget ("OPB"). Barton suggested scheduling another meeting with OPB to review the FY2015 Annual Report, the updated proposal for improvement and other issues.

The Board discussed additional updates to the proposal for improvement. Members were invited to submit draft suggestions for discussion on Friday, September 11.

The Board discussed seeking a legislative change to become an administratively attached agency.

The Board discussed the need for an alternative to discipline program. Members discussed funding barriers that have been previously encountered. The Board will continue to review the objective and consider submitted proposals.

The Board discussed paying for board members to attend committee meetings (i.e. Education Committee, APRN Committee).

The Board discussed the current position statement on Family Nurse Practitioners Practicing in Acute Care Settings.

BOARD SELF ASSESSMENT

Board members completed a self-assessment tool prior to the meeting. Members reviewed the tool and discussed suggestions for improvement. Board members discussed the need for a designated time at each meeting to discuss strategic initiatives. Board members discussed the need for a more comprehensive orientation program for new members. Fort and Shilling agreed to review the current orientation material and make suggested improvements.

NCLEX PASS RATES

The Board reviewed and discussed the year to date NCLEX pass rates for nursing education programs. Members expressed concern regarding some programs. It was noted that some of the program with the lowest pass rates were admitting multiple cohorts per year. The Board will continue to monitor the situation.

APPLICATION FEES

The Board reviewed the current fee structure for registered and licensed practical nurses. Lockwood moved to adopt the fee structure as presented below:

Hooper seconded the motion and it carried unanimously.

LISA DURDEN, PROFESSIONAL LICENSING BOARDS DIVISION DIRECTOR

Durden provided information regarding the recent website outage. She explained that the outage was due to scheduled maintenance and noted that she was uncertain as to how long the system would be unavailable.

Durden provided information regarding the upcoming RN/APRN renewal period and noted that the goal was to have the renewal website available by September 15.

Board members expressed their appreciation for the dedicated call center. Barton inquired about the implementation of a customer satisfaction survey as part of the call center experience. Durden stated that implementation of a survey would require involvement from IT staff members. She explained that IT was currently working on the RN/APRN renewals while also working on an upgrade to My License Office and that they would be unable to take on any additional projects at this time. Rowe explained that the Board was very appreciative of the dedicated call center but noted that board members were interested in whether or not callers were receiving the information that was needed. Barton offered to assist in the development of a survey.

Rowe discussed the difficulty that users experience when attempting to locate the Board's website. Durden noted that the issues had been communicated to the IT staff. Board members noted that while no communication had been received regarding the issue, the website was now searchable using some of the major search engines.

Stephanie Aponte, Call Center Manager joined the meeting and Rowe commended her great work with the dedicated call center. Board members discussed the positive feedback regarding the reduced wait time and the benefit of having agents knowledgeable about nursing regulatory issues. Rowe questioned Aponte about implementing a customer satisfaction survey for callers. Rowe explained that the Board was under the impression that the new call center software that was being utilized would provide a survey option. Aponte was uncertain whether or not a survey option was included in the current software but agreed to contact IT staff members to see if it was a possibility. Barton asked if it was feasible to determine a projected date for implementation of a caller satisfaction survey. Durden explained that the upgrade to My License Office was going to be labor intensive and would require significant IT resources.

Barton thanked Durden and the Secretary of State's Office for allowing Cleghorn to participate with the National Council of State Boards of Nursing ("NCSBN"). Durden noted that Cleghorn would be traveling to Dubai in November 2015 to represent NCSBN at the International Council of Nurses Regulatory Forum. Board members reaffirmed their support for Cleghorn and his position on the NCSBN Board of Directors. Durden discussed the resources and benefits that had been obtained by Georgia due to Cleghorn's participation with NCSBN.

Barton discussed the Board's FY2015 Annual Report and asked if the Board would be able to have input into Cleghorn's performance evaluation. Durden agreed and explained that employee evaluations are completed in June prior to the end of the fiscal year. Barton requested that the standard evaluation form be provided so that the Board could determine the appropriate areas to address and provide feedback regarding Cleghorn's performance.

Durden discussed the upcoming continuing competency requirements and expressed concerns about the workload that would be absorbed by board staff. She noted that she had discussed the issue with Cleghorn and expressed appreciation for the steps that the Board had taken to notify licensees about the new requirements. Rowe explained that the Board understood that difficulties would be encountered any time a new process was introduced to such a large population. Barton inquired as to whether or not Secretary Kemp had been briefed on the potential impact of the new continuing competency requirements.

Rowe thanked Durden and Aponte for their time and noted the Board's appreciation for the improvements that have been made to date. She explained that the Board continued to review processes and search for ways that additional improvements could be implemented.

GEORGIA NURSES ASSOCIATION

Rowe recognized Richard Lamphier, Georgia Nurses Association ("GNA") board member. Lamphier provided information regarding the upcoming GNA meeting in Columbus. He explained that the association's legislative agenda would be developed at that meeting. Lamphier will be presenting information to GNA membership regarding the Nurse Licensure Compact. Board members inquired about whether or not GNA would support a legislative change to move the Board from the Secretary of State's office and make it an administratively attached agency. Lamphier explained that the GNA Board of Directors would meet on Saturday, September 12 and discuss issues pertaining to the Board including current funding and administrative structure. He invited the Board to provide him with additional information to take to the GNA Board of Directors. Rowe agreed to provide him with information regarding the Board's updated proposal for improvement.

Rowe discussed the Nurse Licensure Compact and noted that it was a topic that the Board was considering. Cleghorn provided an overview of the enhanced Nurse Licensure Compact that the Board voted to support in May 2015.

Rowe invited GNA to review the current funding used for the Board. She believed the information would be helpful to GNA as it considers its legislative agenda.

Rowe inquired about the current GNA membership. Lamphier states that he believes that membership has increased approximately 7% over the last three years and agreed to provide an exact number of members.

APRN DISCUSSION

Suzanne Staebler joined the meeting by teleconference. Rowe introduced Staebler to board members and guests and explained that she was working with key groups to remove barriers to APRN practice in Georgia. Rowe invited Staebler to share information regarding her perspective on the difference between APRN practice in Georgia and other states. Staebler explained that she had been a nurse practitioner for almost twenty-four years and had most recently practiced in Texas. She noted that her specialty was neonatology and that she had previously served as the neonatal representative at the APRN Consensus Model discussions. She stated that it was her desire to see Georgia become a full practice authority state for APRNs. She provided information regarding her recent election to the GNA Board of Directors as APRN Representative and discussed the recent creation of an APRN Roundtable for members of all APRN roles to participate.

Staebler discussed the Board’s lack of regulatory authority over post licensure nursing education programs and expressed concerns regarding out of state programs utilizing clinical preceptorships in Georgia. She asked board members to consider how the Board can facilitate the use of Georgia preceptorship sites for Georgia students while managing the use of Georgia preceptorship sites by out of state programs.

Staebler discussed the Board’s current lack of budgetary input and oversight and its administrative structure with the Secretary of State’s office. Staebler states that she has received comments regarding the Board’s situation from colleges and schools of nursing, association groups, legislative and policy members.

Cathy Williams, Albany State University faculty member, provided information regarding that program’s difficulty in securing preceptors for students. She discussed the Board’s lack of regulatory authority over post licensure nursing education programs and noted that there did not appear to be an immediate solution.

Barton discussed the long term implications of changing the Board’s administrative structure. Staebler noted that it would require a substantial amount of political capital to secure a legislative change to revise the Board’s administrative structure. She noted that if a large amount of political capital was to be expended she hoped that it would lead to full practice authority for APRNs and ensure access to health care for all Georgians.

Shilling inquired about the involvement of other APRN roles. Staebler explained that she would have a better idea at the end of the calendar year and noted that the APRN Roundtable was meeting again in October. She expressed that there had been a very positive response from APRN leaders.

Rowe thanked Staebler for her time and efforts and referred her to Cleghorn if additional resources were needed.

Middle Georgia State University

The Board received notification that the Georgia Board of Regents had approved a revised mission for Middle Georgia State College and, effective July 1, 2015, the institution would be known as Middle Georgia State University.

West Georgia Technical College

The Board received notification that Kylie Yearwood had resigned as Program Director for the PN program at West Georgia Technical College effective July 31, 2015. Cecilia Owens will serve as the Interim Program Director. Based on compliance with Board Rule 400-3-.08 it was recommended that the Board approve the change.

University of North Georgia

The Board received a request from the University of North Georgia to extend Board approval. The program is accredited by ACEN through 2016 and has a four year average NCLEX pass rate of 89.69%. Based on that information, it was recommended that the Board extend program approval through December 31, 2016.

Albany State University

At its July 15-17, 2015 meeting, the Board reviewed a request from Albany State University for continued program approval. The Board requested additional information regarding the program including program retention and attrition rates. The information was reviewed by Dr. Rayburn and it was recommended that the Board extend approval through December 31, 2021.

Fort moved to accept all recommendations as provided in the Education Report. Barton seconded the motion and it carried unanimously.

The Board discussed the issue of fraudulent verifications of licensure. Cleghorn provided information regarding recent conversations with the Massachusetts Board of Nursing where applicants had submitted a fraudulent verification of licensure claiming licensure in Georgia. Board members discussed a need for a secure way to transmit verifications of licensure to other jurisdictions.

Board members discussed that Nursys would provide a secure means for verifications of licensure to be transmitted to other boards of nursing and noted that it would be convenient for licensees because it was an online service available at any time. Additionally, it was noted that the verification would be immediately available to other boards of nursing.

Floyd moved that the Board begin utilizing Nursys for verifications of licensure. Hooper seconded the motion and it carried unanimously. The Board directed Cleghorn to correspond with the Secretary of State's office regarding the change and inquire about the date of implementation.
