Program Approval

Georgia Gwinnett College

Georgia Gwinnett College has initial approval and graduated its first cohort on May 13, 2016. 23 students graduated and took the exam resulting in a pass rate of 82.61%. The program is seeking accreditation through CCNE. Based on compliance with Board Rule 410-8-.02(1)(d) it is recommended that the Board grant full approval through December 31, 2020.

Gwinnett Technical College

The Board received notification that ACEN had granted continuing accreditation to the associate degree in nursing program at Gwinnett Technical College through spring 2024. Current Board approval expires December 31, 2016. The four year NCLEX pass rate is 91.65%. The 2016 year to date pass rate is 98.41%. It is recommended that the Board extend approval through December 31, 2024.

Lagrange College

The Board received notification that ACEN had granted continuing accreditation to the baccalaureate degree in nursing program at Lagrange College and placed the program on conditions. A follow up report must be submitted to ACEN in two (2) years. If accepted, accreditation would be continued through 2024. Current Board approval expires December 31, 2016. The four year NCLEX pass rate is 90.52%. The 2016 year to date pass rate is 90.91%. It is recommended that the Board extend approval through December 31, 2024 and require the program to submit documentation of compliance with ACEN conditions.

Berry College

Berry College graduated its first cohort on May 9, 2015. 15 students graduated and took the exam resulting in a pass rate of below 80% for first time writers. Based on Board Rule 410-8-.02(1)(e) the program was placed on conditional approval.

The second cohort graduated on May 7, 2016. 28 students graduated and took the exam resulting in a pass rate of 92.85%. The program is accredited by CCNE through June 30, 2020. Based on compliance with Board Rule 410-8-.02(1)(d) it is recommended that the Board grant full approval through December 31, 2020.

Substantive Changes

Columbus State University

The Board received notification that Janet Alexander had been named director of the nursing education program at Columbus State University. Based on compliance with Board Rule 410-8-.05 it is recommended that you accept the change.

Darton State College

The Board received notification that Larecia Gill had been named director of the nursing education program at Darton State College. Based on compliance with Board Rule 410-8-.05 it is recommended that you accept the change.

Albany Technical College

The Board received notification that, effective August 17, 2016, the practical nursing education program at Albany Technical College will begin admitting one cohort per year. The program will remain the same with a fifteen month completion plan for all students. No action is required.

Georgia Highlands College

The Board received notification that Dr. Michelle Boyce had been named interim Dean for Health Sciences at Georgia Highlands College. It is anticipated that the interim dean will be in place for a period of up to eighteen (18) months. Based on compliance with Board Rule 410-8-.05 it is recommended that you accept the change.

Atlanta Technical College

Atlanta Technical College is proposing a curriculum change in the ASN program that will decrease the credit hours from 72 to 66. The proposal includes the following changes:

- a. Propose the elimination of RNSG 1302 Professional Practice II –Health Assessment (3 credit hours) because the content in the course is also being taught in all the clinical nursing courses.
- b. Propose eliminating the clinical component of RNSG 1308 Professional Practice IX – Transition, Leadership, & Management in Nursing and reducing credit hours from 5 to 2.
- c. These changes will reduce credit hours for the nursing component of the ASN degree program from 45 to 39.
- d. Total program credit hours would decrease from 72 credit hours to 66 credit hours.

Based on compliance with Board Rule 410-8-.04, it is recommended that the Board approve the change in curriculum.

Rowe seconded the motion and it carried unanimously.

Developing Programs

Andrew College

Andrew College has submitted a second report since it was granted developmental approval at the July 2016 meeting.

1. Substantive changes since the program received developmental approval from the GBON:

ATTORNEY GENERAL'S OPINION – O.C.G.A. §43-26-5(17)

Izlar provided a brief summary of the events surrounding the Secretary of State's planned change of executive director that caused the Board to request an official opinion from the Attorney General's Office regarding the authority contained in O.C.G.A. §43-26-5(17). She read the preamble of the official opinion and noted that it was received on August 31, 2016. Izlar provided information regarding the Secretary of State's August 25, 2016 request for a meeting with Izlar and Hooper and noted that the Board was appreciative of the Secretary's desire to meet with the Board's leadership. Izlar explained that the meeting was scheduled for September 19, 2016 and invited stakeholders to submit any suggestions for agenda topics.

Shilling inquired if the Secretary of State's Office had communicated with the Board regarding the Attorney General's official opinion. Izlar stated that she had received no communication from the Secretary of State regarding the official opinion.

Daughdril clarified that only a candidate approved by the Board could serve as executive director of the board of nursing and noted that the authority to approve a candidate also carried the authority to disapprove a candidate.

NURSE PRACTICE COMMITTEE REPORT

The Nurse Practice Committee held its first meeting on Thursday, August 4, 2016. In attendance were committee members, representatives from the Georgia Department of Public Health, Georgia Department of Education, and the Georgia Hospital Association.

The committee had a discussion with representatives from the Georgia Department of Education (GDE) and the Georgia Department of Public Health (GDPH) regarding school nurses. The conversation was intended to establish a relationship between those agencies and Board representatives. GDE and GDPH representatives explained that school nurses were unique in that they were not practicing in a traditional environment and were hired, employed and received direction from non-medical personnel. The committee is reviewing resources from other boards of nursing that can be made available for school nurses in Georgia.

The committee reviewed the current Assignment Tree for Unlicensed Assistive Personnel and will research available resources to determine if updates are necessary.

The committee reviewed the current Scope of Practice Decision Tree and will research available resources to determine if updates are necessary.

The committee reviewed correspondence from Tammy Burdeaux referred by the Board at its May 2016 meeting. Committee members are writing an article for the winter edition of *The Georgian Nurse* regarding the issue.

The committee discussed the definition of "supervision" as provided in O.C.G.A. §43-26-32(7). The committee did not believe a formal definition of the word was needed and recommended that inquiries be referred back to the employer.

The next meeting is scheduled for November 1, 2016.

CORRESPONDENCE

The Board reviewed correspondence from the Georgia Department of Education. Members noted that, while they understood the dilemma, the issue was outside of the scope of the Board's regulatory authority.

PETITION WAIVER – CLAYTON STATE UNIVERSITY

The Board reviewed a petition for waiver or variance of board rules submitted by Clayton State University Reentry Program. The Board discussed the petition and agreed to table the issue until Friday, September 9, 2016.

NATIONAL COUNCIL OF STATE BOARDS OF NURSING

Floyd provided a brief presentation summarizing educational content obtained during the 2016 NCSBN Annual Delegate Assembly.

STRATEGIC PLANNING

Proposed Continuing Competency Rule

The Board discussed promulgating rules regarding the continuing competency process for licensure renewal. The Board discussed the process for recognizing additional certifying bodies. Board members will research the issue and bring additional information for discussion in November 2016.

Proposed Policies

The Board reviewed proposed language to allow staff to share with law enforcement agencies certain information regarding applicants and licensees to include name, address, email address, phone number, date of birth and social security number. A law enforcement agency is defined as a local, state or federal government agency or bureau responsible for the enforcement of laws. The Board referred the proposed language to the Attorney General's Office for review.

The Board discussed the need for a policy regarding cease and desist orders issued by investigators without a vote of the Board. Daughdril explained that a policy was not necessary if the investigators only serve cease and desist orders after a vote of the Board.

Committee Charges

The Board reviewed and approved the following committee charges for the Nursing Education Committee:

- Review RN-BSN Articulation Model
- Review NCSBN model rules for simulation
- Consider development of an orientation program for new deans and directors
- Consider development of pool of educators to participate in site visits

The Board discussed the following potential topics for the APRN Committee:

- Education regarding O.C.G.A. §§43-34-23 and 43-34-25

PROPOSED ALTERNATIVE TO DISCIPLINE PROGRAM

The Board discussed the use of the Affinity eHealth for monitoring licensees with no diagnosis of substance use dependence who are not required to participate in a formal aftercare program. The Board discussed the use of Affinity eHealth for aftercare reporting for licensees participating in the Georgia Nurses Association's Peer Assistance Program.

There being no further business, the meeting adjourned on Thursday, September 8, 2016 at 5:15 p.m.

NURSE LICENSURE COMPACT

The Board discussed the Nurse Licensure Compact (NLC) and affirmed its support of the Georgia Nurses Association's legislative pursuit of the NLC. Lamphier noted that the NLC was a legislative priority for the 2017 session.

ATTORNEY GENERAL'S OPINION – O.C.G.A. §43-26-5(17)

The Board discussed the Attorney General's official opinion regarding the authority contained in O.C.G.A. §43-26-5(17). Daughdril noted that only an individual approved by the Board could serve as executive director. Shilling inquired about the force of the official opinion. Daughdril explained that it was binding on the affected agencies and that the Attorney General would take the position that the opinion was binding. Barton inquired about the next steps for the Board.

Izlar requested that the Board send a formal response to Secretary Kemp regarding the official opinion prior to the scheduled September 19, 2016 meeting with Secretary Kemp, Izlar and Hooper. Board members commented that the correspondence should note that the Board was very willing to help develop a cross training plan to educate other staff regarding the operations of the Board of Nursing but the Board was not willing to accept replacement of its executive director. Barton reiterated that the correspondence be clear regarding the difference in cross training and replacement. Daughdril clarified that the statute contemplated that there would be only one executive director.

Board members discussed the need for an experienced executive director to lead the implementation of the Nurse Licensure Compact if it was passed during the 2017 legislative session.

Rowe, Hooper and Izlar agreed to draft the Board's correspondence to Secretary Kemp to include a request for reconsideration regarding the replacement of the Board's executive director.

MISCELLANEOUS

The Board discussed the agenda for the September 19, 2016 meeting with Secretary Kemp, Izlar and Hooper.

Sandra Copeland, Georgia College and State University, inquired about mandatory reporting and discussed the possibility of a student failing drug screens while enrolled in prelicensure programs.

Barton expressed concern, in light of the Attorney General's official opinion, for staff to be reporting to Turnage. Izlar agreed and noted that the issue needed to be discussed with Secretary Kemp.

Lamphier inquired about the Board's vote of nonapproval of Turnage. Izlar referenced the Board's June 27, 2016 vote. Izlar noted that the July 2016 correspondence from Secretary Kemp and the July 21, 2016 comments from Chuck Harper stated that the transition of executive directors would not begin until 2017. She noted that the staff currently reported to Turnage rather than Cleghorn and reiterated that the Board has one executive director approved by the board and one candidate not approved by the board.

Rowe commented that individual board members were receiving inquiries regarding the situation and noted that the Board was investigating its options and do what was best to protect the citizens of Georgia. She explained that a definitive plan would be shared after the Board finalized development.

Izlar stated that the Board was very resolved on the issue of its executive director and wanted to move forward. Hooper recognized that the issue was counterproductive to moving forward and making additional improvements.

Lamphier questioned Turnage about who provided his direction. Turnage stated that he and Cleghorn reported directly to Lisa Durden, Professional Licensing Boards Division Director. Lamphier inquired about who was overseeing the Georgia State Board of Cosmetology and Barbers. Turnage explained that cosmetology staff members were currently reporting to another staff member. Rowe questioned if Durden instructed Turnage to supervise nursing staff. Turnage replied that he understood his direction came from Durden.

EXECUTIVE SESSION

Hooper moved, Barton seconded and the Board voted to enter into **Executive Session** in accordance with O.C.G.A. §§ 43-1-2(k); 43-1-19(h), 43-26-5(c) and 43-26-11, to deliberate on applications and enforcement matters and to receive information on applications, investigative reports and pending cases. The motion passed unanimously.

At the conclusion of the Executive Session on Friday, September 9, 2016 Izlar declared the meeting to be "open" pursuant to the Open and Public Meeting Act, O.C.G.A. §§ 50-14-1 et seq. No votes were taken during executive session.


CASE REVIEW
