**Attorney General's Open Session** – Ms. Janet Wray

- Ms. Wray advised that licensed Audiologist do not have to acquire and/or maintain a hearing aid dealer's license for their practice location. The Board requested that information on this issue be provided to Dr. Robin Harden. Ms. Wray further advised that the Board may want to update its Board Rule on this issue. Ms. Martin, Executive Director, will work on a draft of the Board's rule to bring back to the Board July 2011 Board meeting.

**Executive Session**
