Dr. Kaplan motioned, Ms. Hudson seconded, and the Board voted to approve the minutes for November 3, 2014 as presented. None opposed, motion carried.

Executive Director's Report: No report presented

Dr. Kaplan motioned, Ms. Chatelain seconded, and the Board voted to continue the hearing in the case of Jennifer Alsdorf, docket # 2014-1689; to accept the Voluntary Surrender upon receipt, and docketing the order surrendering the license. None opposed, motion carried.

Ms. Chatelain motioned, Ms. Pritcher-Ross seconded, and the Board voted for the Executive Director to accept and sign the voluntary surrender on behalf of the Chair of the board. None opposed, motion carried.
