

**Georgia State Board of Registration of Used Motor Vehicle Dealers and
Used Motor Vehicle Parts Dealers
Meeting
May 17, 2006**

**Minutes Approved at the July 19, 2006 Used Car Division & September 7, 2006
Used Parts Division Meetings**

The Georgia State Board of Registration of Used Motor Vehicle Dealers and Used Motor Vehicle Parts Dealers held their joint meeting on May 17, 2006 at 237 Coliseum Drive, Macon, Georgia. Ms. Waldrop called the meeting to order at 10:05 AM. A quorum was established with the following board members present:

Election of Officer (Chair for joint meeting)

Mr. Griggers moved to nominate Mr. Sapp as Chair for the full board. Mr. Wilkinson seconded the motion. There being no other nominations, the motion carried. Mr. Sapp was elected Chair of the full board for the joint meeting.

Approval of Used Motor Vehicle Dealers Board Minutes:

Mr. Wilkinson moved to approve the Minutes of the March 15, 2006 Meeting. Mr. Ausburn seconded the motion. The motion carried.

Exam Committee

Dr. Femi Ajayi with the Exam Development & Testing Section discussed guidelines with the board they may want to consider when developing exam procedures.

Discussion of Board Rules

Mr. Lindsey informed members that pre-inspections are being performed for the Used Car Division and Used Parts Division applications, as well as licensee requests for change of location and/or change of business name. The Board gave its approval of the procedure.

Jackie Turner shared with the Board positive results of pre-inspections. Ms. Turner stated that less than half of the pre-inspections recently performed were not in compliance as an “established place of business”. She and inspectors asked board members to clarify “established place of business” with specific attention on separate entrance of two businesses at the same location; definition of suites; and permanent signage.

The Board stated that “established place of business” requires a permanent sign identifying the business name and must be visible from the outside.
