

**Minutes for Used Motor Vehicle Dealers Division
July 19, 2006**

Minutes Approved at the September 20, 2006 Meeting

Other Business:

The Board discussed preliminary site inspections for compliance. It was the Board's decision that effective July 20, 2006, preliminary site inspections will only be performed for new applicants and license holders requesting a change of location. This action will reduce the need to inspect a reinstatement applicant, a change of designee, and a business name change at the same location prior to approval of the change. License holders with both a used motor vehicle dealers license and a used motor vehicle parts dealers license at the same location will not be required to have a separate business entrance. The Board asked the board staff to notify all providers to inform their students to submit applications only when they have met all the requirements for an established place of business.

The Board continues to discuss signage rules.
