A meeting of the Georgia State Board of Registration of Used Motor Vehicle Dealers was held on Wednesday, March 21, 2012 at the Professional Licensing Boards Office located in Macon, GA. Chairman Jeff Wilkinson called the meeting to order at 10:00 a.m.

A quorum was established with members present being Jeff Wilkinson, Chairman; Dewell Sanford, Jonathan Shoemaker, Alex Grovenstein, Lewis Page, Ruth Flemister with the Governor’s Office of Consumer Affairs, and Douglas Hooper with the Georgia Department of Revenue.
