**Public Hearings:**

A public hearing was held by the Georgia State Board of Registration of Used Motor Vehicle Dealers on January 16, 2013, for the purpose of providing licensees the opportunity to appeal fines assessed for inspection violations. The hearings were held at the office of the Professional Licensing Boards Division, 237 Coliseum Drive, Macon, GA. The Board chairman, Jeff Wilkinson, called the hearings to order at 10:15 a.m. A quorum of the Board was established with members Jeff Wilkinson, Dewell Sanford, Doug Hooper, Jonathan Shoemaker, and Ruth Flemister with the Governor's Office of Consumer Affairs.
