Public Hearings:

A public hearing was held by the Georgia State Board of Registration of Used Motor Vehicle Dealers on May 8, 2013, for the purpose of providing licensees the opportunity to appeal fines assessed for inspection violations. The hearings were held at the office of the Professional Licensing Boards Division, 237 Coliseum Drive, Macon, GA. The Board chairman, Jeff Wilkinson, called the hearings to order at 10:15 a.m. A quorum of the Board was established with members Jeff Wilkinson, Dewell Sanford, Doug Hooper, Alex Grovenstein and Ruth Flemister.

At the conclusion of the hearings, the Board rendered the following decisions on each case:

Atlanta Best Auto Collection LLC: Doug Hooper moved, Alex Grovenstein seconded, and the Board voted to uphold a total fine of \$3250.

HRM Auto Sales: Alex Grovenstein moved, Doug Hooper seconded, and the Board voted to waive the fine of in full.

Select Luxury Motor Inc: Ruth Flemister moved, Doug Hooper seconded, and the Board voted to uphold a total fine of \$2000.

Bivins Complete Automotives: Dewell Sanford moved, Alex Grovenstein seconded, and the Board voted to waive fine in full and re inspect in 30 days to determine if the establishment is separated from another business.

Buy Rite Auto Sales: Ruth Flemister moved, Doug Hooper seconded, and the Board voted to uphold a fine of \$500 for 2 buyer guides. The fine must be paid within 90 days.

Oak City Autos: Doug Hooper moved, Alex Grovenstein seconded, and the Board voted to uphold a fine of \$500 for 2 buyer guides.

Finish Line Auto Sales: Ruth Flemister moved, Dewell Sanford seconded, and the Board voted to uphold a fine of \$1500 for 6 buyer guides.

Hayden Sosebee Used Cars & Trucks: Alex Grovenstein moved, Doug Hooper seconded, and the Board voted to uphold a fine of \$500 for failure to maintain a surety bond and to refer the establishment to the Attorney General's office for suspension until proof of bond is provided.

Fair Brothers Auto LLC: Dewell Sanford moved, Doug Hooper seconded, and the Board voted to uphold a fine of \$4250 for open titles and no proof of buyer guides and waive fines for no proof of a certificate of insurance and a surety bond.

Doug Hooper, moved to enter into Executive Session to deliberate on applications, complaints, and investigations, as authorized by O.C.G.A. § 43-1-2 (k) and 43-1-19 (h). Ruth Flemister seconded the motion. The motion was carried by Jeff Wilkinson, Chairman; Dewell Sanford, Doug Hooper, Alex Grovenstein and Ruth Flemister. The Board concluded Executive Session in order to vote on the matters discussed and to continue with the public session.
