Board Meeting

Public Hearings:

A public hearing was held by the Georgia State Board of Registration of Used Motor Vehicle Dealers on September 18, 2013, for the purpose of providing licensees the opportunity to appeal fines assessed for inspection violations. The hearings were held at the office of the Professional Licensing Boards Division, 237 Coliseum Drive, Macon, GA. The Board chairman, Jeff Wilkinson, called the hearings to order at 10:06 a.m. A quorum of the Board was established with members Jeff Wilkinson, Dewell Sanford, Lewis Page, Alex Grovenstein, Jon Shoemaker and Ruth Flemister.

At the conclusion of the hearings, the Board rendered the following decisions on each case:

Gold Coast Import Outlet: Ruth Flemister moved, Dewell Sanford seconded, and the Board voted to waive the fine for no license at the location, to uphold 9 buyer guides and to waive the remainder of the buyer guides. The total for the fine is: \$2250.

Auto – Pro Sales & Service: Ruth Flemister moved, Dewell Sanford seconded, and the Board voted to waive the fine in full.

Buyavette: Alex Grovenstein moved, Lewis Page seconded, and the Board voted to uphold the fine for failure to change the address and to waive the fine for Certificate of Insurance. The total amount for the fine is \$250.

Blue Light Car Sales Inc: The Board tabled until next meeting.

Zed Autos: Alex Grovenstein moved, Dewell Sanford seconded, and the Board voted to uphold 15 buyer guides, to waive the fine on failure to provide tag documents, and to uphold the fine for failure to transfer the title. The total amount for the fine is: \$4250.
