

# Georgia State Board of Registration of Used Motor Vehicle Dealers

## Board Meeting

November 6, 2013

### Public Hearings:

A public hearing was held by the Georgia State Board of Registration of Used Motor Vehicle Dealers on November 6, 2013, for the purpose of providing licensees the opportunity to appeal fines assessed for inspection violations. The hearings were held at the office of the Professional Licensing Boards Division, 237 Coliseum Drive, Macon, GA. The Board chairman, Jeff Wilkinson, called the hearings to order at 10:10 a.m. A quorum of the Board was established with members Jeff Wilkinson, Dewell Sanford, Lewis Page, Douglas Hooper, Jon Shoemaker and Tashia Zeigler, who attended via teleconference.

At the conclusion of the hearings, the Board rendered the following decisions on each case:

**All Motors LLC:** Jon Shoemaker moved, Lewis Page seconded, and the Board voted to waive the fine in full.

**Genesis Truck Sales LLC:** Jon Shoemaker moved, Dewell Sanford seconded, and the Board voted to refer to Attorney General's Office for Consent Order with a payment schedule of \$250 a month for 3 months. The total amount is: \$ 750.00

**Planet Motor Cars:** Jon Shoemaker moved, Lewis Page seconded, and the Board voted to uphold the fine in full. The total amount is: \$ 750.00
