Board Meeting

Public Hearings:

A public hearing was held by the Georgia State Board of Registration of Used Motor Vehicle Dealers on January 8, 2014, for the purpose of providing licensees the opportunity to appeal fines assessed for inspection violations. The hearings were held at the office of the Professional Licensing Boards Division, 237 Coliseum Drive, Macon, GA. The Board chairman, Jeff Wilkinson, called the hearings to order at 10:05 a.m. A quorum of the Board was established with members Jeff Wilkinson, Dewell Sanford, Alex Grovenstein, Jon Shoemaker, Douglas Hooper and Ruth Flemister.

At the conclusion of the hearings, the Board rendered the following decisions on each case:

A & B Luxury Motors: Ruth Flemister moved, Jon Shoemaker seconded, and the Board voted to uphold the fine in full. The total for the fine is: \$1500.

Georgia Auto Sales: Alex Grovenstein moved, Jon Shoemaker seconded, and the Board voted to uphold 2 FTC Buyer Guides, 4 Failures to apply for a title in the retail purchaser's name within thirty days after sale date, and to waive the remainder of the fine. The total of the fine is: \$2500.

National Discount Auto Sales: Douglas Hooper moved, Alex Grovenstein seconded, and the Board voted to waive the fine in full.

R & R Used Cars: Alex Grovenstein moved, Douglas Hooper seconded, and the Board voted to uphold 2 FTC Buyer Guides and to waive 4 FTC Buyer Guides. The total of the fine is \$500.

Rocky Top Auto Sales: Dewell Sanford moved, Douglas Hooper seconded, and the Board voted to accept the fine money of \$500.

T & K Auto Brokers: Alex Grovenstein moved, Douglas Hooper seconded, and the Board voted to uphold the fine in full. The total of the fine is \$500.
