Public Hearings:

A public hearing was held by the Georgia State Board of Registration of Used Motor Vehicle Dealers on September 17, 2014, for the purpose of providing licensees the opportunity to appeal fines assessed for inspection violations. Douglas Hooper moved, and Alex Grovenstein seconded, and the Board voted unanimously to deny the application for seminar presented by E- Learning Concepts for content that is inadequate to comply with Board rules. Jeff Wilkinson recused himself from discussion and abstained from the vote.
