

Georgia State Board of Registration of Used Motor Vehicle Parts Dealers  
Meeting  
October 2, 2008

A meeting of The Used Motor Vehicle Dealers and Used Motor Vehicle Parts Dealers (Used Parts Division) was held on October 2, 2008 at 237 Coliseum Drive, Macon, Georgia. Mr. Robert Griggers, Chairman, called the meeting to order at 10:05 AM.
