

**Georgia State Board of Registration of
Used Motor Vehicle Parts Dealers
Board Meeting
December 1, 2011**

Public Hearings:

Public hearings were conducted by the Georgia State Board of Registration of Used Motor Vehicle Parts Dealers on December 1, 2011 at the Professional Licensing Boards Office in Macon, Georgia, for the purpose of allowing licensees to appeal citation fines assessed as a result of inspections. Chairman Robert Griggers called the hearings to order at 10:00 a.m.

Kenneth Belcher with A & B Auto Salvage Inc. appeared before the Board to appeal a citation of \$2500 for open titles. During the hearing, Mr. Belcher submitted evidence that the Board took into consideration. The Board also heard from the inspector concerning the citation. After discussion, Mr. Hon moved, Mr. Sumner seconded, and the Board voted to waive the fine in total and to advise the licensee that titles must be turned in within 72 hours of removing parts from the vehicles.

Representatives from Exotic Auto L Brokers, Inc. did not appear for the scheduled hearing.
