

**GEORGIA STATE BOARD OF REGISTRATION OF USED MOTOR VEHICLE PARTS
DEALERS
BOARD MEETING
December 5, 2013**

Public Hearing:

A public hearing was held by the Georgia State Board of Registration of Used Motor Vehicle Parts Dealers on December 5, 2013, for the purpose of providing licensees the opportunity to appeal fines assessed for inspection violations. The hearings were held at the office of the Professional Licensing Boards Division, 237 Coliseum Drive, Macon, GA. The Board chairman, Robert Griggers, called the hearings to order at 10:10 a.m. A quorum of the Board was established with members Robert Griggers, Butch Hon, Gene Sapp, Sidney McLeod, Bobby Holton, Michael Rosser and Doug Hooper with the Georgia Department of Revenue. Others present were as follows: Steve Lindsey, Executive Director, Amantha Lovett, Board Support Specialist and Byron Thernes, Assistant Attorney General. Anthony Cabbie, Inspector with the Secretary of State's office, and Lori Young, Inspector with the Secretary of State's office, were also present via remote satellite.

At the conclusion of the hearings, Gene Sapp moved, Sidney McLeod seconded, and the Board voted unanimously to enter Executive Session to deliberate on the citation appeal. At the conclusion of Executive Session, Chairman Griggers declared the meeting back into Open Session. The Board rendered the following decisions on the case:

Omega Auto Center Inc.: Michael Rosser moved, Gene Sapp seconded, and the Board voted to reduce the fine to \$1000 for failure to furnish appropriate documents for tag transfer to retail purchaser with thirty (30) days of purchase date. The Board waived the 7 Buyer Guides.

A to Z Auto Salvage Dismantlers Rebuilders & Parts: Michael Rosser moved, Gene Sapp seconded, and the Board voted to waive the fine in full. In lieu of appearing, the licensee presented information that in the Board's view did not warrant a fine.

Chase Star Auto, Inc.: No vote was taken, as the licensee did not appear for the scheduled hearing.

At the conclusion of the vote, Chairman Griggers declared the hearing adjourned, and the Board convened the scheduled meeting.

A meeting of The Georgia State Board of Registration of Used Motor Vehicle Parts Dealers was held on December 5, 2013 at the Professional Licensing Boards Office in Macon, Georgia. Robert Griggers, Chairman, called the meeting to order at 10:42 a.m.
