

**Georgia State Board of Registration of

**Public Hearing:**

A public hearing was held by the Georgia State Board of Registration of Used Motor Vehicle Parts Dealers on April 3, 2014 for the purpose of providing licensees the opportunity to appeal fines assessed for inspection violations. The hearings were held at the office of the Professional Licensing Boards Division, 237 Coliseum Drive, Macon, GA. The Board chairman, Robert Griggers, called the hearings to order at 10:36 a.m. A quorum of the Board was established with members Robert Griggers, Michael Rosser, Butch Hon, Gene Sapp, Sidney McLeod, and Doug Hooper with the Georgia Department of Revenue. Others present were as follows: Steve Lindsey, Executive Director, Grechelle Blocker, Board Support Specialist and Byron Thernes, Assistant Attorney General. Anthony Cabble, Inspector with the Secretary of State's office, was also present via remote satellite.
