- **C.E. approval request:** Dr. Hines presented a request for continuing education credits for license renewal that he received from a licensee. The Board requested that the licensee be contacted informing him that the information must be translated into English before the Board would consider for approval.
- **GVMA Legislative Action Committee:**
 Representatives from the committee discussed possible changes to legislation:
 - Scope of practice for regulated & non-regulated employees. Any action on this item is pending advice from the AG's office. When the advice is ready, the Board will have a conference call to discuss.
 - Remove the grandfather clause regarding allowing for Vet Tech registration based on the on-the-job experience.
 - Add the term "homeopathy" from OCGA 43-50-3(11)(A)
