



INFORMATION FOR APPLICANTS FOR GEOLOGISTS EXAMINATION

Applicants for examination in Georgia now take the National Association of State Boards of Geology (ASBOG®) national examination for registration in Georgia. The Board believes that, since the ASBOG® examination is widely accepted as satisfying the examination requirement in other states, using the ASBOG® examination in Georgia will facilitate reciprocity for Georgia registered geologists.

The ASBOG® Examination consists of two parts. Part I, Fundamentals of Geology (FG), can be taken after the education requirement is completed. Part II, Practice of Geology (PG), can be taken after the work experience, as well as educational, requirements are completed. Candidates who passed either Part I or Part II of the Georgia Examination will only be required to pass the remaining part of the ASBOG® Examination.

Secure and Verifiable Documents Under O.C.G.A. § 50-36-2
Issued August 1, 2011 by the Office of the Attorney General, Georgia

The Illegal Immigration Reform and Enforcement Act of 2011 (“IIREA”) provides that “[n]ot later than August 1, 2011, the Attorney General shall provide and make public on the Department of Law’s website a list of acceptable secure and verifiable documents. The list shall be reviewed and updated annually by the Attorney General.” O.C.G.A. § 50-36-2(f). The Attorney General may modify this list on a more frequent basis, if necessary.
