Checks returned for insufficient funds will be assessed a service charge pursuant to O.C.G.A. § 16-9-20. ■ All Examination fees are to be paid directly to the examination vendor, <u>not to the Board.</u> ■ ALL requests for a name change (no charge) must be in writing to the Board and include a COPY of the legal document changing the name. There is a \$25 fee to request a new license pocket card reflecting the name change.
