**Mr. Hoff motioned, Dr. Malone seconded, and the Board voted to accept the Executive Directors report as presented. None opposed, motion carried**

**Board Rule 53-6-.03 Reinstatement:** Mr. Zimmerman presented a draft of changes to rule 53-6-.03 to assist in the administrative processing of the applications for reinstatement. After discussion, and minor changes to the draft version, the Board agreed to post the rule for amendment as discussed.

#### **53-6-.03 Reinstatement.**

A license which is revoked for failure to renew may be reinstated upon the discretion of the Board within two years from its expiration date upon receipt of a reinstatement application, verification of forty (40) hours Continuing Education obtained within two years of the date of the reinstatement application and the reinstatement fee. A license which is expired for two years or more ~~cannot be renewed or may be reinstated; at the discretion of the Board through meeting current licensure requirements, submission of a reinstatement application, the required fee and verification of forty (40) hours of Continuing Education obtained within two years of the date of the reinstatement application. Any consideration for re-licensure will require submission of a new application and will require the applicant to satisfy the then-existent requirements.~~

**Mr. Hoff motioned, Mr. White seconded and the Board voted to post the revisions to Board rule 53-6-.03 Reinstatement upon receipt of the AG's Memo of Authority for the required thirty day minimum with a Board vote/public hearing to be held the next scheduled meeting in December. None opposed, motion carried.**

**Mr. Hoff motioned, and Dr. White seconded, and the Board voted to enter into Executive Session in accordance with O.C.G.A. § 43-1-2(k) (1) (2), O.C.G.A. § 50-14-2(1), O.C.G.A. § 43-1-2-(k) (4), O.C.G.A. § 43-1-19 (h) (2) & (4) to receive and review information pertaining to Applications, receive the Attorney General's, Cognizant, and Enforcement Reports. Voting in favor of the motion were those present who included Board members Hoff, Bair, White and Malone.**

At the conclusion of Executive Session on Monday, September 10, 2012, Mr. Hoff declared the meeting to be “open” pursuant to the Open and Public Meeting Act O.C.G.A. § 50-14-1 et seq. No votes were obtained during Executive Session.
