Minutes Approved at August 29, 2005 Meeting

The Georgia Auctioneers Commission held its regular meeting on June 27, 2005 at 237 Coliseum Drive, Macon, Georgia. Chairman Terry Hansford called the meeting to order at 10:05 a.m.

Approval of Minutes:

Mr. Gay made a motion to accept the minutes of the April 18, 2005 meeting. Mr. Cates seconded the motion. Motion carried.

AUCT050009

Mrs. Cates moved to issue a consent agreement with a public reprimand and a fine of \$10,000 for violation of Board Rule 55-10-.01. Mr. Gay seconded the motion. Motion carried, with Mr. Echols voting against the motion.

AUCT030015 & AUCT050033

Mr. Manley moved to issue a consent agreement for reinstatement of license with a public reprimand, fine of \$1,000 for practicing without a license, \$4,000 for administrative cost from the previous voided consent order on AUCT030015, and to issue a separate letter of concern regarding the auctioning practices of the respondent. Mr. Echols seconded. Motion failed with Mrs. Jones, Mr. Cates and Mr. Gay voting against the motion.

Mr. Cates moved to issue a consent agreement for reinstatement of license with a public reprimand, fine of \$4,500 for practicing without a license, \$4,000 for administrative cost from the previous voided consent order on AUCT030015, and to issue a separate letter of concern regarding their auctioning practices of the respondent. Mr. Gay seconded. Motion carried with Mr. Echols voting against the motion.

Other Business:

Mr. Cates moved to accept the Voluntary Cease and Desist Order on Ray V. Bartley doing business as Bo Auction Company for practicing without a license, flag the information in the licensing system, and fine him \$250 when he applies for a license. Mr. Gay seconded. Motion carried.

Continuing Education

Mr. Manley moved to approve continuing education for the Southeastern School of Auctioneer pending submission of an approved course outline. Mr. Gay seconded. Motion carried.

Mr. Lindsey reviewed the Cost vs. Revenue Analysis for the Auctioneer Commission. This will be revisited at the next meeting.

The Commission briefly discussed EBay drop-off stores and whether licensure is required for such establishments. The Commission agreed to discuss the issue in more depth at the August 29 meeting.

The Commission expressed appreciation to Ms. Constance Jones for her contributions to the Commission during her tenure as a Commission member. This is Ms. Jones' final meeting with the Commission.
