**Kay Kendrick moved, John Siggers seconded, and the Board voted unanimously** to accept the following Consent Orders: Maria A Joyner, Arvin R Gera, Starkelia Lloyd.

The Board recommended that SC/schoolhours submit documents such as financial aid information from when she attended school, old tests, old notes, to the Board for review.

**Kay Kendrick moved, John Siggers seconded, and the Board voted unanimously** to require the master supervisor to appear before the Board regarding the apprenticeship of TS/apprentice.

**Kay Kendrick moved, John Siggers seconded and the Board voted unanimously** to refer correspondence regarding the licenses of PB/mas/inst to Enforcement for investigation.

**Kay Kendrick moved, Betty Carlisle seconded, and the Board voted unanimously** to request that correspondence is sent to CBC/school and EBS/school acknowledging receipt of the letters and informing them that the Board has no jurisdiction in the matters addressed in the letters.

### **Old Business**

Eleanor Surrency and Janet Jackson informed the Board that posting of rule revisions is still in process. The Cosmetology rules on the web site must be updated.

Rule 130-2-.12(2)(g) will be revised at the February 1, 2006 Cosmetology Board meeting.

**Kay Kendrick moved, Cynthia Stein seconded and the Board voted unanimously** to request inquiries are sent to the producers professional or professional affiliated hair shows and conferences held in Georgia to find out who has been representing the Board at these functions.

**Kay Kendrick moved, Don Westbrooks seconded, and the Board voted unanimously** to offer language for a proposed “grandfather clause” for Cosmetology legislation regarding hair braiders as follows:  
”persons residing in the State of Georgia who are actively practicing hair braiding in Georgia on the effective date of this legislation shall be exempt from meeting the requirements of licensure as a hairbraider before being issued a license as a hair braider by the board.

Such persons shall submit an application for licensure as a hair braider and shall be issued a license upon documentation , to the satisfaction of the board, that the applicant meets the requirements of this exemption. Persons who are issued a license pursuant to this exemption must comply with all requirements for license renewal.

Persons who are exempt from licensure as a hair braider under this Code section shall not be exempt from licensure required for other professions or facilities under the provisions of Chapter 10 of Title 43 including, but not limited to, licensure for cosmetology shops and salons.

Exemption from licensure provided in this Code section shall not be granted after one year from the effectiveness date of this legislation.

#### **New Business**

DL Roope appeared to discuss the details of her contract to administer the examinations for the Georgia State Board of Cosmetology. The Board voted as follows:
