**Kay Kendrick moved, Cynthia Stein seconded, and the Board voted unanimously** to approve the minutes from the Feb.1, 2006 Board meeting.

Martha Harris called for a vote to adopt rule revisions.

**Kay Kendrick moved, Wanda Brooks seconded, and the Board voted unanimously** that the formulation and adoption of these rules does not impose excessive regulatory cost on any licensee and any cost to comply with the proposed rule cannot be reduced by a less expensive alternative that fully accomplishes the objective of **O.C.G.A. §43-10-1, 43-10-2 and 43-10-9(a)** and that it is not legal or feasible to meet the objectives of **O.C.G.A. §43-10-1, 43-10-2 and 43-10-9(a)** to adopt or implement differing actions for business as listed at **O.C.G.A. §50-13-4(3)(A), (B), (C), & (D)** and that the formulation and adoption of these rules will impact every licensee in the same manner and each licensee is independently licensed, owned, and operated in the field of Cosmetology, Nail Care, and Esthetics.

**Kay Kendrick moved, Betty Carlisle seconded, and the Board voted unanimously** to adopt rule 130-2-.07 as posted.

**Kay Kendrick moved, Wanda Brooks seconded, and the Board voted unanimously** to establish a policy that the following forms are posted in all Cosmetology establishments in Georgia effective new rule date:

ALL COSMETOLOGY SERVICES SHALL ONLY BE PERFORMED ON INTACT, HEALTHY SKIN AND NAILS.

ANY RAZOR-LIKE IMPLEMENT, SUCH AS CREDO BLADES, SHALL NOT BE USED TO PREVENT THE RISK OF INJURY OR INFECTION.

PUMICE STONES SHALL NOT BE REUSED FROM ONE CUSTOMER TO ANOTHER TO PREVENT THE SPREAD OF BACTERIA.

The above signs shall be posted in the reception area of the salon/shop and each Cosmetology, Esthetic and Nail Care school. These signs shall be available for public view at all times.

The following sign shall be posted in the Pedicure area of the salon/shop recommending that consumers:

NOT SHAVE THEIR LEGS THE SAME DAY AS RECEIVING PEDICURE SERVICES TO REDUCE THE RISK OF INFECTION.

ALL NAIL SERVICES SHALL ONLY BE PERFORMED ON INTACT, HEALTHY SKIN AND NAILS.

ANY RAZOR-LIKE IMPLEMENT, SUCH AS CREDO BLADES, SHALL NOT BE USED TO PREVENT THE RISK OF INJURY OR INFECTION.

PUMICE STONES SHALL NOT BE REUSED FROM ONE CUSTOMER TO ANOTHER TO PREVENT THE SPREAD OF BACTERIA

A record or log book containing the dates and times of all pedicure cleaning and disinfection procedures for all units must be documented and kept in the pedicure area by the salon or shop and made available for review upon request by a consumer and or an inspector from the Board
