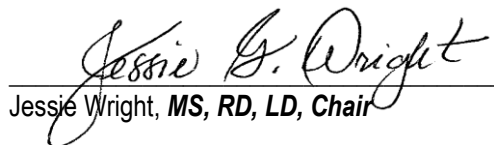
APPLICATIONS APPROVED BY STAFF GUIDELINES
