

Georgia State Board of Funeral Service Minutes
December 11, 2007

A meeting of The Georgia State Board of Funeral Service was held on December 11, 2007 at 237 Coliseum Drive, Macon, Georgia. Draper Watson, Chairman, called the meeting to order at 10:06 a.m.

A quorum was established with members present being: Draper Watson, Chairman, David Roach, Terry Daviston, Thelon Hamby, Linda Ware, and Nancy Kennedy.

Others present were as follows: Steve Lindsey, Executive Director, Reagan Dean, Assistant Attorney General, JoAnn Lyde, Application Specialist, and Laurie Elander, Board Secretary.

Approval of Minutes:

Ms. Kennedy moved, Ms. Ware seconded, and the Board approved the minutes of the October 16, 2007 meeting.

Mr. Daviston moved, Ms. Kennedy seconded, and the Board approved the minutes of the November 16, 2007 Conference Call.

Mr. Watson introduced to the Board Randall D. Vaughn the new Division Director of the Professional Licensing Boards Division.

Mr. Watson gave a brief summary of the meeting with Secretary of State, Karen Handel and all board chairpersons.

Ms. Ware moved, Ms. Kennedy seconded, and the Board made the decision to table discussion of a letter from the Cremation Society of the South until the next meeting.

Mr. Reagan Dean, Assistant Attorney General, presented a review by his office of the proposed rule 250-7-.04, "Unlawful Acts." Mr. Dean advised the Board to make a change of language used in the rule. After discussion of the rule, Ms. Ware moved, Mr. Hamby seconded, and the Board made the decision to rescind the vote to amend Rule as stated in the October meeting.

Ms. Ware moved, Mr. Hamby seconded, and the Board made the decision to amend rule 250-7-.04 (4) to read "legally authorized person" in place of "legal next of kin" as stated in the October 16, 2007 meeting. The proposed rule will read as follows:

Rule 250-7-.04 Unlawful Acts.

- (1) It shall be unlawful for any funeral establishment, funeral director or embalmer to refuse to surrender immediately the custody of a dead human body to a legally authorized person upon request of that person, but the release of such body shall not constitute a release of any indebtedness or other claim owed for any legally authorized services performed on that body by the person releasing that body.

- (2) It shall be unlawful for any funeral establishment, funeral director or embalmer to refuse to surrender immediately the custody of cremated remains to a legally authorized person upon request of that person, but the release of such cremated remains shall not constitute a release of any indebtedness or other claim owed for any legally authorized services performed on that deceased body and/or cremated remains by the person releasing the cremated remains.
- (3) It shall be unlawful for any funeral establishment, funeral director or embalmer to intentionally delay or withhold the filing of a death certificate as a means to facilitate payment of any or all services rendered by the funeral establishment, funeral director or embalmer, but the prompt filing of a death certificate shall not constitute a release of any indebtedness or other claim owed for any legally authorized services performed on that deceased body and/or cremated remains by the person filing the death certificate.
- (4) It shall be unlawful to perform services for a charge - such as embalming, transportation, dressing and/or handling of the deceased, etc. - unless such services were requested by the legally authorized person, or as required by law.
 - a) any services and/or merchandise requested by the legally authorized person must be in compliance with those listed on the funeral establishment general price list, the casket price list, the outer burial price list, or the funeral service contract price list, and,
 - b) any services and/or merchandise requested by the legally authorized person must be itemized on a funeral service contract and this contract must be signed by the funeral director and the responsible party by the date of the funeral service, cremation, or ship-out. If the responsible party is not physically available to sign the itemized funeral contract by the time services are rendered, a copy of the itemized funeral contract may be faxed to the responsible party for their review and signature, and faxed back to the funeral establishment for inclusion in the funeral home files.

Timothy Watkins appeared before the Board to seek direction for applying for temporary approval to operate from another facility. Watkins & Sons Funeral Home was destroyed by fire on October 1.

Ms. Ware moved, Mr. Hamby seconded, and the Board made the decision to grant a 90-day grace period effective December 11, 2007 for Watkins & Sons Funeral Home to operate from the facilities of Trice Funeral Home in Barnesville, GA.

Executive Session:

Mr. Hamby moved to enter into Executive Session to deliberate on applications, complaints, and investigations, as authorized by OCGA §§ 43-1-2 (k) and 43-1-19 (h). Ms. Kennedy seconded the motion. The motion was carried by Mr. Hamby, Mr. Roach,
